- Credit Instant Invoice


# 1 Company Set-up

## 1.1 Overview

In order to utilize the Czech functionality, the company must be set up as using the Czech Republic localization. This is defined in the page *Company*.

## 1.2 Define localization

- Open the page *Company*.
- Search for the company.
- Select “Czech Republic” in the drop-down list in the Localization field and Save. Note that this cannot be changed once transactions are created for the company.

## 1.3 Select Localization functionality

Specify which functionality to use.

- Open Localization Control Center sub menu under Company.
- The localization selected in previous step is displayed in the Localization Control Center field and cannot be changed.
- All functionality available for Czech Republic is presented in the list. Enable/Disable the functionality based on the requirements for the company by enabling the radio buttons. Note that some functionality is mandatory and cannot be disabled..

## 2 Tax Reliability Control on Suppliers

### 2.1 Overview Legal Requirement

As a measure to prevent tax evasion, companies are obliged to control the reliability of suppliers. As of January 1, 2013, there is a Czech regulation in force that obliges Czech taxpayers to check whether their suppliers are reliable or not. This check is done via a web site ([http://adisreg.mfcr.cz/cgi-bin/adis/idph/int\\_dp\\_prij.cgi?ZPRAC=FDPHI1&poc\\_dic=1](http://adisreg.mfcr.cz/cgi-bin/adis/idph/int_dp_prij.cgi?ZPRAC=FDPHI1&poc_dic=1)).

VAT payers who do not comply with their obligations are considered as "unreliable". Recipients of supplies will be liable for any VAT not paid by suppliers who are identified as "unreliable".

As of April 1, 2013, the Czech taxpayers should also check the validity of the bank account number of the supplier on the above website. According to the Czech law, the taxpayer is only allowed to transfer the payment of the invoice of a certain supplier to the bank account as mentioned on the above website.

There is no legal requirement to have such controls in the companies' ERP solution but best business practice to avoid situations where companies become liable of the VAT that the supplier shall pay to the tax authorities.

### 2.2 Solution Overview

Functionality is added to define if suppliers are considered unreliable and if bank accounts are valid for payments. There are also added controls and warning messages raised in the following scenarios:

- Control of supplier reliability is performed in following scenarios:
  - Purchase order entry
  - Manual supplier invoice entry
  - Creating supplier payment proposal
  - Acknowledging tax proposal
- Control of bank account validity is performed in the following scenarios:
  - Authorizing invoice for payment
  - Creating supplier payment proposals

### 2.3 Prerequisites

- The company must be set up to use Czech Republic localization, see the Company Setup chapter, and the "Tax Reliability Control on Suppliers" parameter must be enabled.

## 2.4 Define the reliability status on the Supplier

After checking the tax authority's database, the user can manually update the supplier basic data via *Application Base Setup/Enterprise/Supplier/Supplier/Address* tab and *Document Tax Information* sub tab.

The following columns are added:

- **Supplier Tax Reliability Status.** Enter the status for the supplier. Values are “Not set”, “Reliable” and “Unreliable”.
- **Supplier’s Tax Reliability Declaration Date.** This is the date the tax authorities have classified the supplier’s reliability. The information is provided via the tax authority’s web site and entered manually.
- **Supplier’s Tax Reliability Status Last Modified.** This is the date when the reliability data was last updated, it’s entered manually.



## 2.5 Define the bank account validity on the Supplier

Supplier reliability status and bank account validation recognized as independent functionalities. Therefore, irrespective of the **Supplier Reliability Status**, electronic payment address's **Account Validation** checkbox can be updated to define the bank account validity on the supplier.

This is defined as supplier basic data via the *Application Base Setup/ Enterprise/ Supplier/ Supplier/ Payment* tab and sub tab *Payment Method*. Open the context menu and select **Electronic Payment Addresses** to open the *Bank Address* page. A new, **Account Validated** check box and **Account Validated Date** fields are added where the user may define if the account is valid or not with the account validated date.

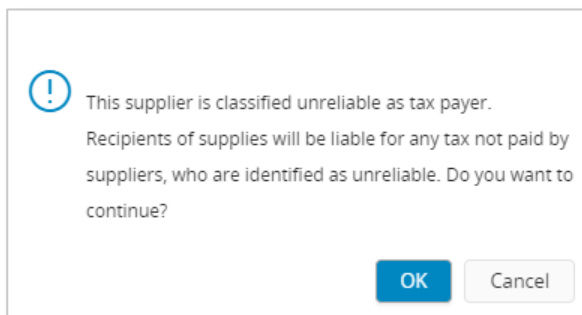


## 2.6 Validation and Warning when entering a purchase order

When creating a new purchase order, the reliability of the supplier is validated.

If the value on the supplier is “Unreliable” a warning message is displayed.



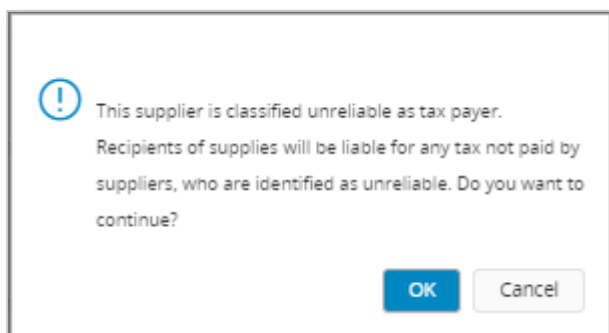
The supplier's document address as defined in the purchase order header will be used to perform the validation.





## 2.7 Validation and Warning when entering a manual supplier invoice

When creating a manual supplier invoice, the reliability of the supplier is validated. If the value on the supplier record is set to “Unreliable” a warning message is displayed when saving the invoice.



The chosen supplier invoice address set for the invoice will be used to perform the validation. This may be changed in *Manual Supplier Invoice* page and the *General Invoice Information* dialog box accessed under the **General Info...** context menu option. The reliability of the selected address is displayed in the **Tax Reliability Status** field.

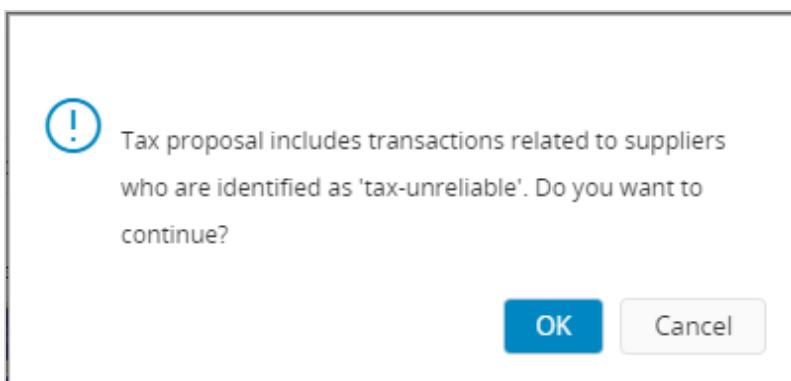

## 2.8 Validation and Warning when acknowledging a Tax Proposal

When acknowledging a tax proposal, the reliability of the supplier is validated. If the value on the supplier record is set to "Unreliable" a warning message is displayed.



To show the tax reliability status in the tax proposal, **Tax Reliability Status** column is added to *Tax Proposal Details* page. This column is automatically updated with the changes in the supplier basic data.

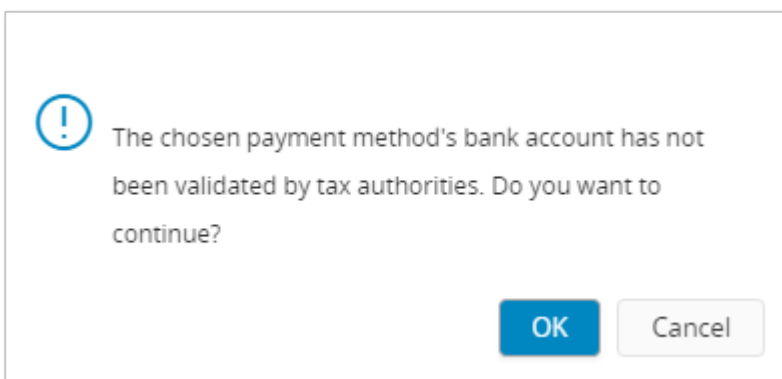



## 2.9 Validation and warning when authorizing invoice for payment

A validation is done to control whether the bank account on the payment method is valid. If the chosen bank account is not valid for the supplier or connected payee for the supplier, a warning message is displayed. The warning is generated at time of authorizing the invoice installment for the payment.



This authorization can be done manually or automatically. This is set up as basic data on the supplier in the *Supplier/Invoice* tab and *General* subtab, this is IFS Cloud standard functionality.



The following options are available:

- “No”. The validation of the account is done when the **Authorize** check box is manually selected in the *Supplier Invoice Installment Plan and Discount* page.
- “At Final Posting”. The validation of the account is done when final postings are created.
- “When Posted” The validation of the account is done when the first postings are created for the invoice.

On company level, on the *Company/Invoice* tab, it's possible to control if invoice authorization should be done in a separate function/page, this is IFS Cloud standard functionality. If the **Supplier Invoice Authorization Only by Separate Function** is enabled the authorization can only be done from the *Authorize Invoices for Payment* page. The validation of the account is performed when the **Authorized** is enabled.

## 2.10 Validation and Warning when creating a Payment Proposal

When creating a new supplier payment proposal, a validation is done to control the reliability status of the supplier and a control is done to check that the account connected to the payment method is valid.

If the supplier or payee is unreliable and/or the account is not valid a warning message is displayed. For the account to be validated, it's required that the invoices are registered with a **Payment Method** and **Payment Address ID**.

The validation is performed in the following scenarios:

- When creating the proposal under the **Create Proposal** context menu option in the *Accounts Payable/Supplier Payment Proposal/Supplier Payment Proposals* page
- When connecting invoices manually in the *Supplier Payment Proposal Details* page in the *Details* tab.

Once the proposal is created you can go to the detail page and view connected invoices. There are five new columns added, **Tax Reliability Status**, **Declaration Date**, **Last Modified**, **Account Validated Date** and **Account Validated**, to indicate the supplier's status. Based on this information decision can be made whether to pay or not before acknowledging the payment.

## 2.11 Delimitations

- There is no online, nor offline connection developed to integrate IFS Cloud with the tax authorities' database.
- This functionality is only available in purchase order entry, manual supplier invoice entry, supplier invoice authorization for payment, payment proposal and tax proposal.

## 3 VAT Control Statement

### 3.1 Overview Legal Requirement

Starting from 1st January 2016 (according to Articles 101c – 101i of Act no.: 235/2004 Coll., on VAT as amended, hereinafter “the VAT Act”), selected entities (taxable persons registered for VAT) are obliged to submit so-called ‘VAT Control Statement’ report.

There is an obligation to submit data from particular tax documents which are already required to be recorded in the tax evidence by the VAT Act. This data will be reported in the VAT Control Statement based on issued and received tax documents (including simplified tax invoices).

Only taxable entities registered for VAT in the Czech Republic (with assigned CZ VAT ID number) will have the obligation to submit the VAT Control Statement.

Transactions which shall be declared in the VAT Control Statement:

1. Domestic taxable supplies (CZ) or receipt of advance payment (lines 1, 2 or 25 of the CZ VAT return)
2. Domestic acquisition of goods/services or providing of advance payment (lines 40, 41 or 10 and 11) of the CZ VAT return
3. Received transactions from which the acquirer is obliged to declare VAT according to article 108 section 1b), c) of the VAT Act (lines 3, 4, 5, 6, 9, 12 and 13 of the CZ VAT return)
4. Special scheme for investment gold:
  - Received Intermediary Service for which VAT is applied according to Article 92 section 5 of the VAT Act
  - Supply of VAT exempt investment gold for which taxable person registered for VAT is entitled to deduct VAT pursuant to Article 92 section 6 b) and c), or
  - Production of investment gold or transformation of gold into investment gold according to Article 92 section 7 of the VAT Act.

### 3.2 Solution

To handle the Czech tax reporting requirement, IFS Cloud standard tax reporting process including the tax transactions and the corresponding tax proposal functionality is used. An xml file is created which can be submitted to the tax authorities.

The VAT Control Statement requires Code of Supply, Fill Mode Code, identification of non-deductible tax amount and Customer Date of Incorporation.

Tax Category 1 and Tax Category 2 are added to support reporting the Code of Supply and Fill Mode Code. IFS Cloud standard functionality is used to identify the non-deductible tax amounts and Date of Registration is used to fetch the date of of incorporation details in Czech Republic VAT reporting.

- The following new data is added for companies in Czech Republic during the installation.

New tax template : "GCZ001 - Czech VAT Control Statement".

New external file type : "TaxRepCZ - Czech Tax Reporting" .

New external file template : "TaxRepCZVatCtrlStmt - Czech Vat control statement"

New tax group : "KH2016 - Czech VAT Control Statement".

New data is generated for tax template "GCZ001" in the *Tax Group* page and the *Tax Template Field Control* page, if STD- CZ- Czech Company Template is used in company creation or company update process.

If STD-CZ company template is used in company creation process, new data is added for the companies with localization variant "**Czech Republic**" is selected in the *Company/General* tab and localization parameter "**Tax Reporting – Czech Republic**" is enabled.

After the company creation, if STD-CZ company template is used for company update process, new data is added to the companies for which the localization variant "**Czech Republic**" is selected in the *Company/General* tab and localization parameter "**Tax Reporting – Czech Republic**" is enabled.

- A new basic data window is added to define the tax categories in *Accounting Rules/Tax/Tax Categories*. Tax categories can be used to classify and group the tax transactions for any reporting purpose.

In Czech Republic localization, **Tax Category 1** can be used for reporting the "**Czech Code of Supply**" and **Tax Category 2** can be used for reporting the "**Fill Mode Code**".

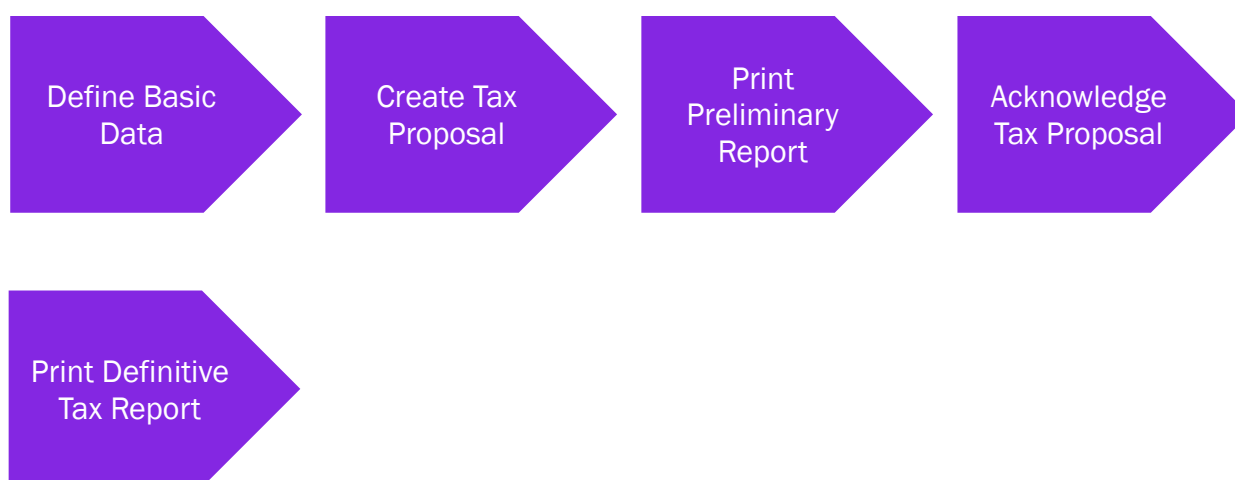
The tax categories can be attached to the tax codes and it is fetched to the invoice lines through tax lines of the customer/supplier invoices. The tax categories can also be changed in tax lines of the invoices. These tax categories are fetched to the tax transactions of the tax ledger in order to be used for tax reporting.

The tax category details are fetched to *Tax Categories* page from the company template.

- A new *VAT Control Header* dialog is added. Use it when the tax report is printed/preliminary printed or re-printed. This dialog is used to specify report/file header details that does not always exist in IFS Cloud standard version.
- The **standard non-deductible functionality** is used to specify a proportional claim of tax deduction under the 75 section in the VAT Statement report.
- New **Date of Registration** field is introduced to the *Customer/General* tab for the customers that are not obliged to pay VAT.
- For the validation of invoice amounts, new **Above Tax Control Limit** option is added to the customer, supplier and project invoices. The same option is also presented in the tax transactions.
- To enter supplier's tax liability date for supplier invoices, the new **VAT Control Report Date** is added to the *Tax Transactions* page.

### 3.3 PREREQUISITES

- The company must be set up to use Czech Republic localization, see the Company Setup chapter and the “VAT Reporting” parameter must be enabled.
- Only transactions in the tax ledger will be subject for the report hence, tax codes must be used accordingly.
- Use STD-CZ company template for company creation or company update process in order to fetch the details of tax groups and subgroups from the company template.


It is an assumption that the user is familiar with the IFS Cloud standard process for tax reporting and have knowledge about country specific requirements i.e. tax consultant type/code, control report data etc.

### 3.4 DEFINE BASIC DATA

To be able to generate the **VAT Control Statement**, some basic data must be set up. The basic data is used both in the header section and in the sub sections of the report.

#### 3.4.1 COMPANY NAME

The company name given for an address identity will be used in the header section. If an extended company name is requested, the name field in *Application Base Setup/ Enterprise/ Company/ Company page Address/ Distribution* tab is being used up to 100 characters and the input in this field will overwrite the company name from the address identity.

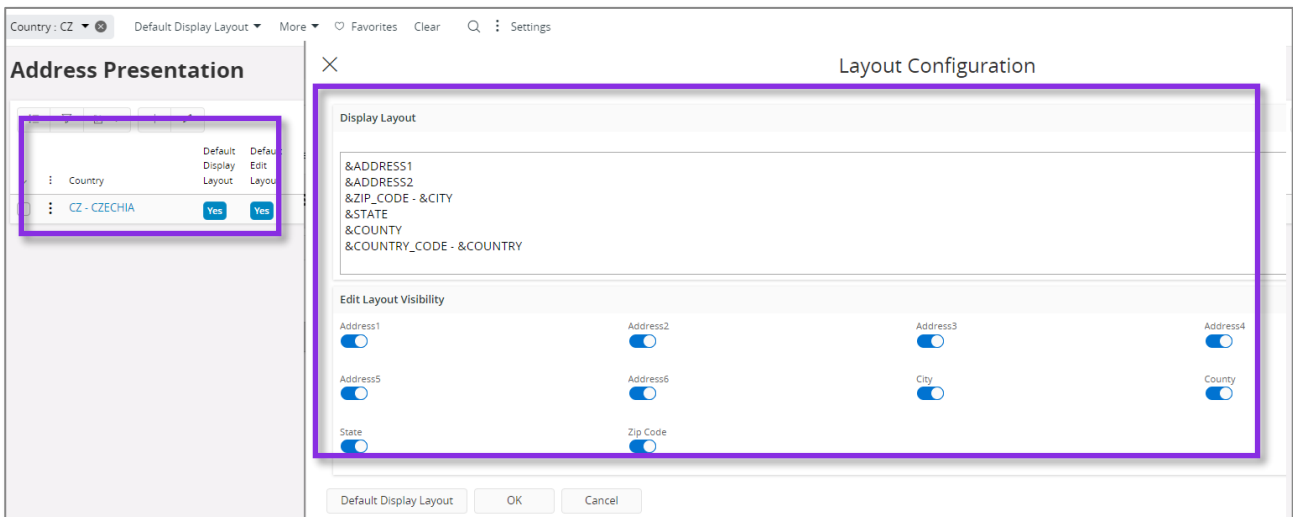

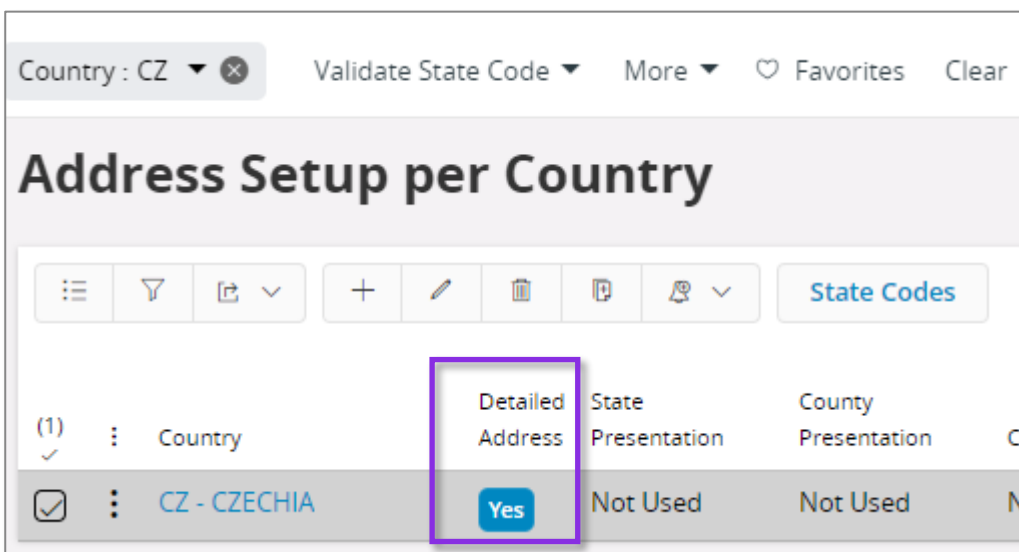
#### 3.4.2 COMPANY ADDRESS

The company address is required in the header section and needs to be entered in a certain way to get the correct information into the correct filed.







For tax office and regional tax office, the standard functionality for adding tax office is used. Go to *Application Base Setup/Enterprise/Tax/Tax Office* page and set up both tax office and regional tax office.

### 3.4.8 CREATE SUB GROUP DETAILS

Tax sub group is where the user connects a tax code with a certain sub section in the statement. The tax group and sub groups are fetched from the company template, if STD-CZ company template is used for company creation or company update process. The sub group details need to be set up by the user. Create a line for each tax code and delivery type that is required for the statement.

Go to *Financials/Tax Ledger/Basic Data/Tax Group page Subgroup Details* tab to add tax codes to the proper subgroup.

- Taxable supplies from which taxable person registered for VAT is obliged to declare tax and supplies in domestic reverse charge regime.
  - A.1. Taxable supplies in domestic reverse charge regime from which an acquirer is obliged to declare tax according to Article 92a of the VAT Act.
  - A.2. Taxable acquisition from which an acquirer is obliged to declare tax according to Article 108 section 1b) and c) (Articles 24 and 25 of the VAT Act).
  - A.3. Supplies in special regime for investment gold according to Article 101c section 1c) point 2 of the VAT Act.

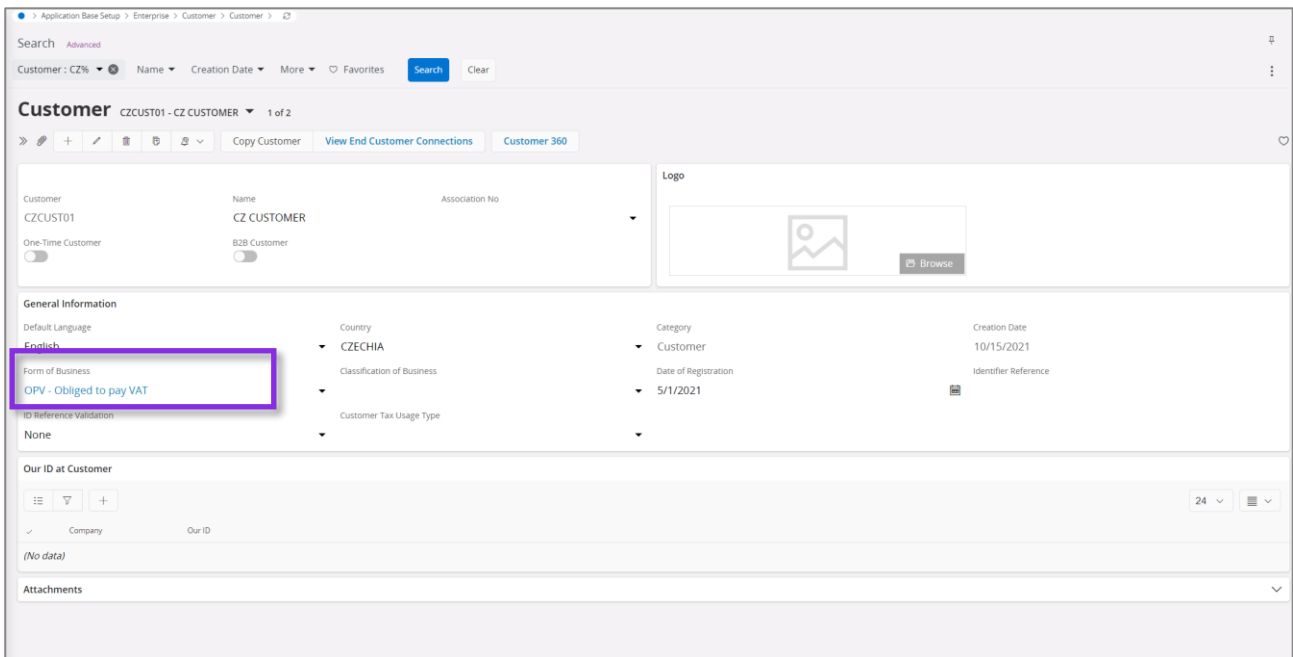

### 3.4.10 FORM OF BUSINESS

Standard version of IFS Cloud provides a functionality to define form of business in *Application Base Setup/Enterprise/Company/Basic Data/Form of Business*. Form of Business could be connected to Customer (on the *Customer/General* tab).

The values in **Form of Business** field are used to indicate whether the customer’s business entity is obliged to pay VAT.

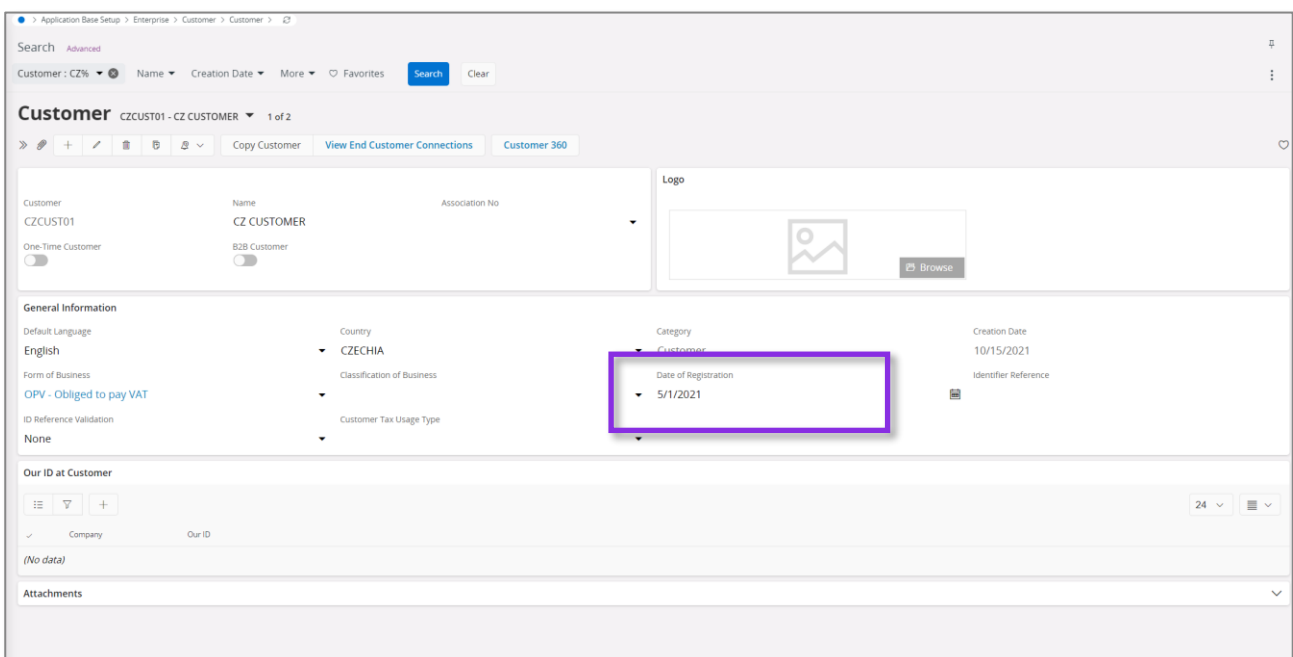

When form of business is equal to NOPV, then in A3 block of XML file, fill tags: `d_narozeni`, `jm_prijm_obch`, `m_pobytu_sidlo` with date of incorporation (see below), customer name, customer address respectively. Otherwise the fields are empty in XML file.

### 3.4.11 CUSTOMER DATE OF INCORPORATION

A new **Date of Registration** field is added to the *Customer/General* tab. Define the date of registration of your customer for the Not Obligated to pay VAT form of business selected.






### 3.4.11.1 Fetch “Date of Registration” to the xml

In VAT Control Statement xml, under the clause, A3, Position: d\_narozeni, the **Date of Registration** is retrieved by validating whether the form of business is NOPV = Not Obligated to Pay VAT. When the form of business = NOPV, then the **Date of Registration** field value is provided and then the customer incorporation date is retrieved to the VAT Control Statement xml file.

### 3.4.12 10,000 CZK LIMIT

There is limit of 10 000 CZK for total amount of the invoice that has an impact on selection of the section in which transaction should be reported. See description of sub groups for details.

The limit should be defined in the **Tax Control Limit in Accounting Currency** field in *Application Base Setup/Enterprise/Company/Tax Control/Invoice* Tab.





- “A” – when “A” is specified in the **Correction Reason ID** field in the *Tax Transactions* page
- “P” – when “P” is specified in the **Correction Reason ID** field in the *Tax Transactions* page
- “N” – otherwise.

### 3.4.14 VAT CONTROL REPORT DATE

To enter supplier's tax liability date for a supplier invoice, the New **VAT Control Report Date** column is added to tax transactions. It is filled with **Delivery Date** field value from supplier invoice.

The same field can be used for customer invoices to handle some special cases like credit notes, returns when tax liability should be entered manually. Therefore, for customer invoices **VAT Control Report Date** column is kept empty. User can enter it manually in special cases.

**VAT Control Report Date** from tax transactions is sent to duzp and dppd tags in all blocks in XML file. When it is empty, then the value from the **Tax Liability Date** is used.

### 3.6.2 HEADER INFORMATION

Some of the company related information for header section of the VAT control statement are taken from the information fields that have been added to the tax template.

**Company Detailed Name** - The extended company name defined field in *Application Base Setup/Enterprise/Company/Company* page *Address/Distribution* tab is used.

**Phone/E mail** of reporting company – The default phone no/E mail connected to the default document address of the company is used. The value with default per method and address is selected.

**House no, Street, Zip code, City and State** – All these address related details are fetched from the default document address of the company.

Note that any of this information can still be modified after creating the tax proposal but before printing the tax report. Use IFS Cloud standard functionality to view and modify the information fields connected to a tax proposal through **Show Information Fields** command in **Automatic Tax Proposal** page.

The Above Tax control limit validation is not applied to manual customer invoice.

## 4 VAT Return Report

### 4.1 OVERVIEW LEGAL REQUIREMENT

It is a legal requirement, for Czech companies to generate different reports for tax office. VAT return report is a report that displays all tax transactions and some specific information. The report is generated as an xml file and is manually uploaded into the governmental portal. The report is divided into the different sections and subsections, each with specific reporting rules.

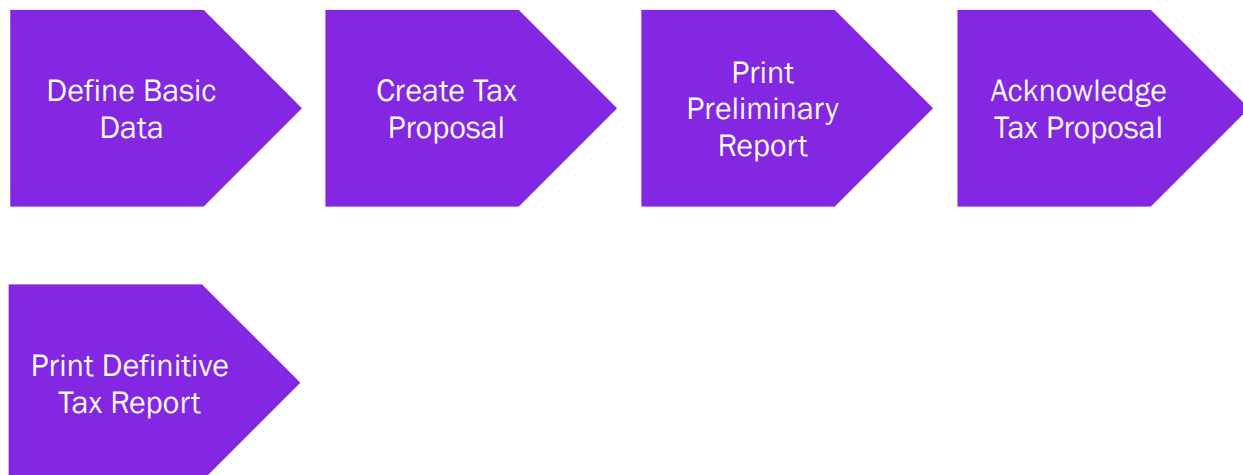
The VAT Return report consists of two different reference reports (tax sales - and tax purchase report) and is generated based on the set up and transactions in these two reports. The report can be generated either monthly or quarterly depending on the company's tax obligations.

### 4.2 SOLUTION

To support these requirements, the following functionalities have been added:

- Dialog for report header information
- Tax templates
- Tax groups and sub group details for reference reports
- Requirements regarding monthly or quarterly reports
- Creation of supplementary/correction reports

- It is an assumption that the user is familiar with IFS Cloud standard process of creating tax reports and tax proposals.

## 4.3 PREREQUISITES


- The company must be set up to use Czech Republic localization, see the Company Setup chapter and the “Tax Reporting- Czech Republic” parameter must be enabled.
- Use STD-CZ company template for company creation or company update process in order to fetch the details of tax groups and subgroups from the company template.

## 4.4 DEFINE BASIC DATA

To be able to generate the VAT report, some basic data must be set up. The basic data is used both in the header section and in the sub sections of the report.

### 4.4.1 COMPANY NAME

The company name given for an address identity will be used in the header section. If an extended company name is requested, the name field in *Application Base Setup /Enterprise /Company /Company page Address/Distribution Data* tab is being used. You can add up to 100 characters and the input in this field will overwrite the company name from the address identity.

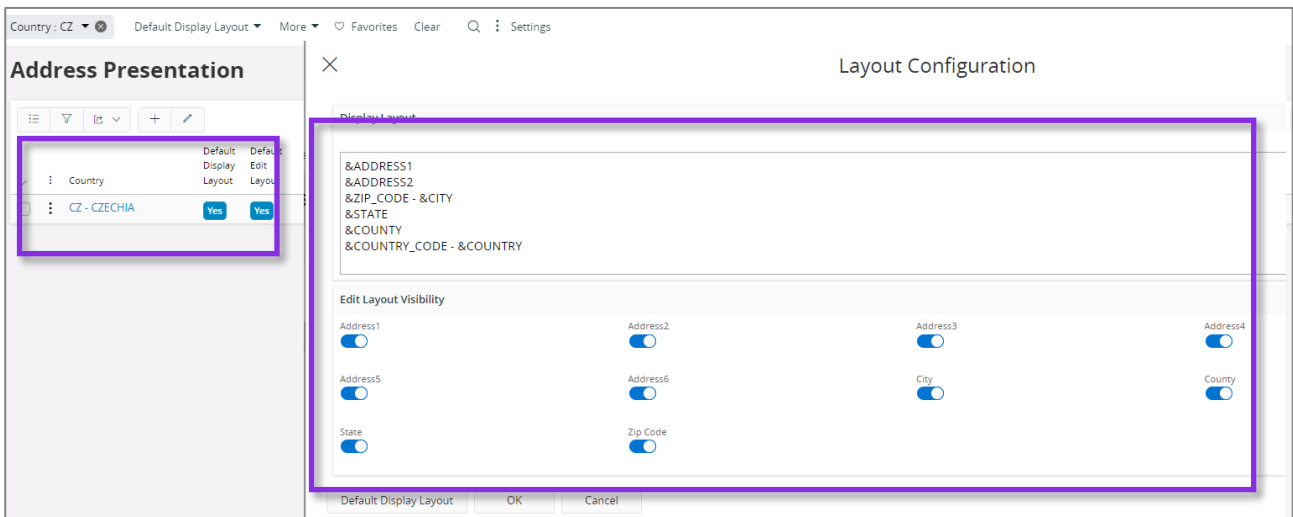

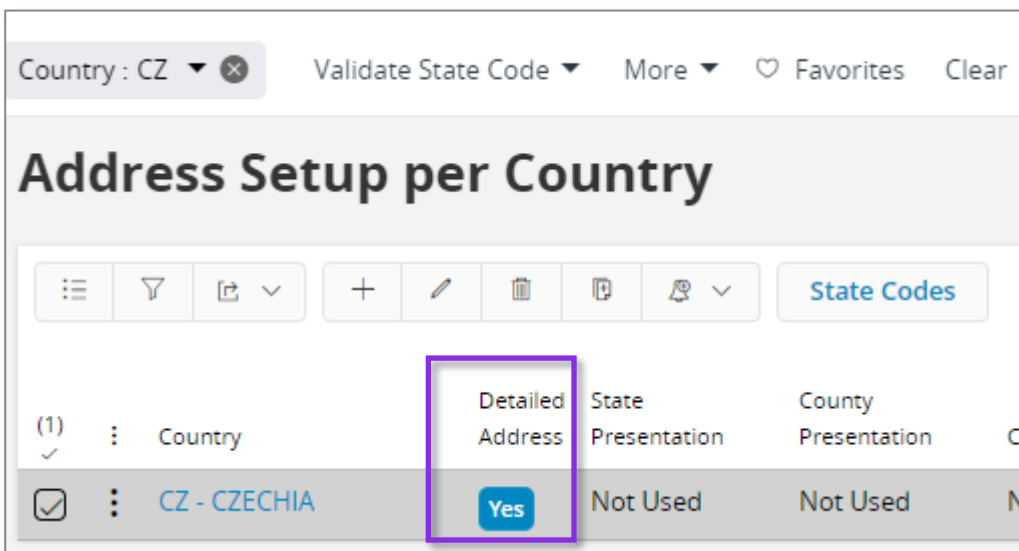
### 4.4.2 COMPANY ADDRESS

The company address is required in the header section and needs to be entered in a certain way to get the correct information into the correct field.

First, the fields for **City**, **Zip Code** and **Country** must be enabled for the Czech Republic country code in *Enterprise/Company/Basic Data/Address Presentation* page.



Second, the functionality for detail address information must be enabled. In *Enterprise/Company/Basic Data/Address Setup per Country* page the check box for **Detailed Address** needs to be checked. The check box will enable dedicated fields for **Street** and **House number** when creating the company address.



Third, enter a customer address in *Application Base Setup/Enterprise/Company/Company* page *Address* tab. The dialog for address details will enable dedicated fields for **Street** and **House number** which is required in the control statement.

#### 4.4.3 TAX ID NUMBER

Tax id numbers are required for company, suppliers and customers and are used as reference in the VAT reports.

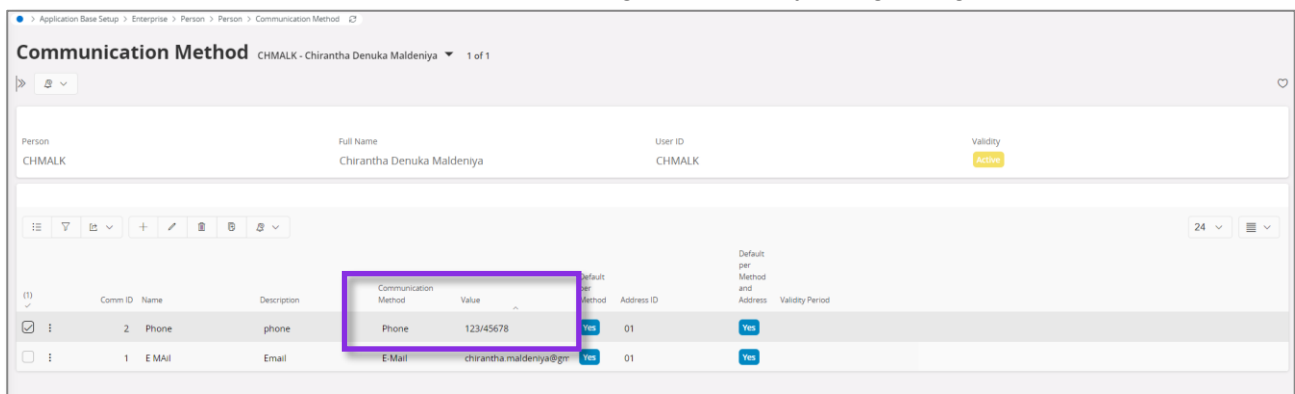

#### 4.4.4 CREATE PERSON ID

The header section of the VAT report requires information about **Contact Person, Tax Consultant, Authorized Person** and **Issued By**. Use standard functionality in *Application Base Setup/Enterprise/Person* page to enter person ids which will be fetched via list of value into the header dialog when printing the tax report.

Note: Phone number must be separated from regional code by using “/” sign.



#### 4.4.5 CREATE TAX REPORT

A specific tax report must be created for the Czech Purchase Tax Report (tax template GCZ003), Czech Sales Tax Report (tax template GCZ004) and Czech VAT Return Report (tax template GCZ002). Use standard functionality in IFS Cloud to create the report in Financials/Tax Ledger/Tax Report page.

If the report is created for a quarter, then the number of periods must be set to 3.

A calculation is done to determine which quarter the report represents:

Last month in the period/3 = Quarter

Ex) Tax period April to June(6) → 6/3 = 2

Note: It is required from the user to create the report according to the calendar year i.e. Q1 = period 1 to 3, Q2 = period 4 to 6 etc.

When creating all tax reports, select “Replacement Report” in the **Correction Type** field, in order to handle corrections before end of the reporting period. Note that this setup will have to be changed to “Supplementary Report” to handle corrections after the end of the reporting period. This is described later in the process.

When creating tax report for Czech VAT Return, make sure that both Tax Sales and Tax Purchase reference reports are connected to the report in the *Ref Reports* tab.

Also note that to make it possible to select “Supplementary Report” for Czech tax reports, an entry with “Correction Proposal” in the **Info Type** field and “Supplementary Report” in the **Info Value** field is added in the *Tax Template Basic Specific Info* page for system defined tax templates GCZ003, GCZ004 and GCZ002 during the installation.

- In case of GCZ003 and GCZ004, which are tax templates based on tax transactions (**Tax Report Based On** field is set to “Tax Transaction” in the *Tax Templates* page), this is standard possibility. Any user defined tax template based on tax transactions can be setup this way.
- In case of GCZ002, which is a tax template based on other reports, Tax Sales and Tax Purchase (**Tax Report Based On** field is set to “Other Reports” in the *Tax Templates* page), this is an extended functionality. For user defined tax templates based on other reports, this setup can only be defined if the tax template is GCZ002 and it was created as a copy of GCZ002 (see **Org Template Id** field). Functionality related to this new setup is described later in the process.

#### 4.4.7 CREATE TAX CODES

A tax code is needed for each type of transaction, and it is the tax code that direct a certain transaction into a certain sub section of the statement. Separate tax codes for disbursed (sales) and received (purchase) tax is required. A tax code is being created according to standard process in *Accounting Rules/Tax/Tax Codes* page.

Note: A tax code can only be connected to one tax sub group, but it is possible to direct a transaction in to another sub section by adding a delivery type i.e. for a credit or correction transaction.

#### 4.4.8 CREATE SUB GROUP DETAILS

Tax sub group is where the user connects a tax code with a certain sub section in the statement. The tax group and sub groups are fetched from the company template, if STD-CZ company template is used for company creation or company update process. The sub group details need to be set up by the user. Create a line for each tax code and delivery type that is required for the statement.

The VAT return report does not have its own tax group, instead it uses two different reference tax groups.

Go to *Financials/Tax Ledger/Basic Data/Tax Group* page and search for each of the tax group id's below and set up the sub group details.

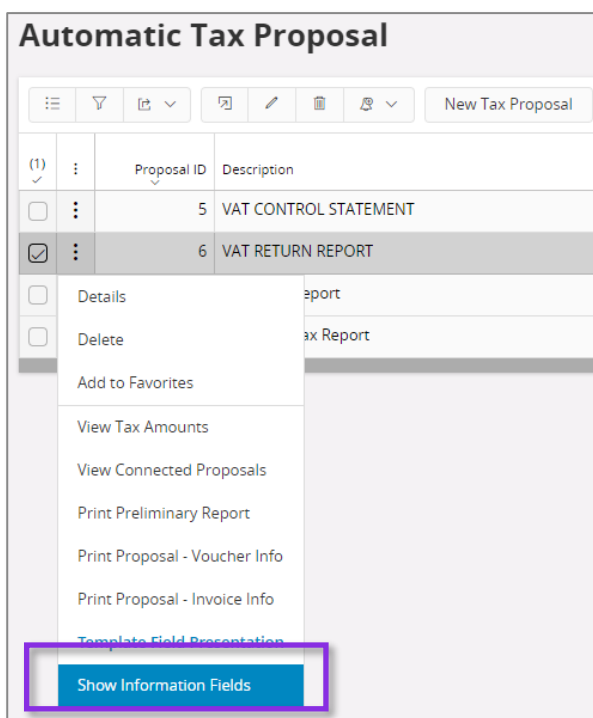
Some of the company related information for header section of the VAT control statement are taken from the information fields that have been added to the tax template.

**Company Detailed Name** - The extended company name defined field in *Application Base Setup/Enterprise/Company/Company* page *Address/Distribution* tab is used.

**Phone/E mail** of reporting company – The default phone no/E mail connected to the default document address of the company is used. The value with default per method and address is selected.

**House no, Street, Zip code, City and State** – All these address related details are fetched from the default document address of the company.

Note that any of this information can still be modified after creating the tax proposal but before printing the tax report. Use IFS Cloud standard functionality to view and modify the information fields connected to a tax proposal through **Show Information Fields** command in **Automatic Tax Proposal** page.

## 5 VAT Summary Report

### 5.1 OVERVIEW LEGAL REQUIREMENT

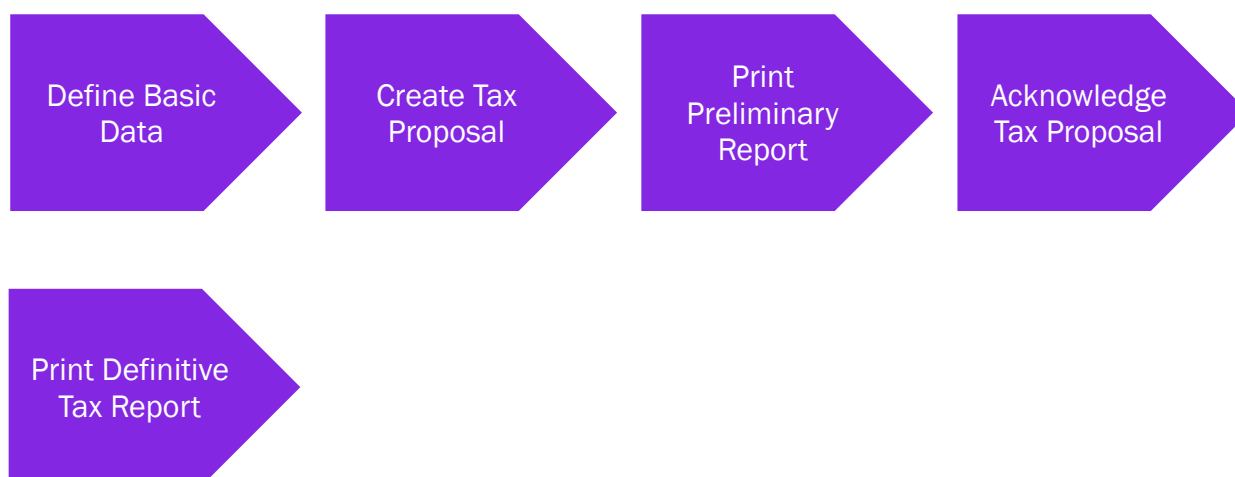
It is a legal requirement, for Czech companies to generate different reports for tax office. VAT summary report displays a customer's tax transactions inside EU (VIES). VIES is an electrical system allowing information regarding VAT registration to be transferred between countries. The report can be generated either monthly or quarterly depending on the company's tax obligations.

### 5.2 SOLUTION

An xml file is created which can be submitted to tax authorities. To support the full requirement, the following have been added:

- New tax template : "GCZ007 - Czech VAT Summary Report "
- New external file type : "TaxRepCZ - Czech Tax Reporting" .
- New external file template : " TaxRepCZVatSum - Czech VAT Summary Report File "
- New tax group : "CZ\_SUM\_REP- Czech VAT Summary Report".

### 5.3 PREREQUISITES


- The company must be set up to use Czech Republic localization, see the Company Setup chapter and the "VAT Reporting" parameter must be enabled
- Use STD-CZ company template for company creation or company update process to fetch the details of tax groups and subgroups from the company template.

## 5.4 DEFINE BASIC DATA

To be able to generate the VAT report, some basic data must be set up. The basic data is used both in the header section and in the sub sections of the report.

### 5.4.1 COMPANY NAME

The company name given for an address identity will be used in the header section. If an extended company name is requested, the name field in *Application Base Setup /Enterprise /Company /Company page Address/Distribution* tab is being used. You can add up to 100 characters and the input in this field will overwrite the company name from the address identity.

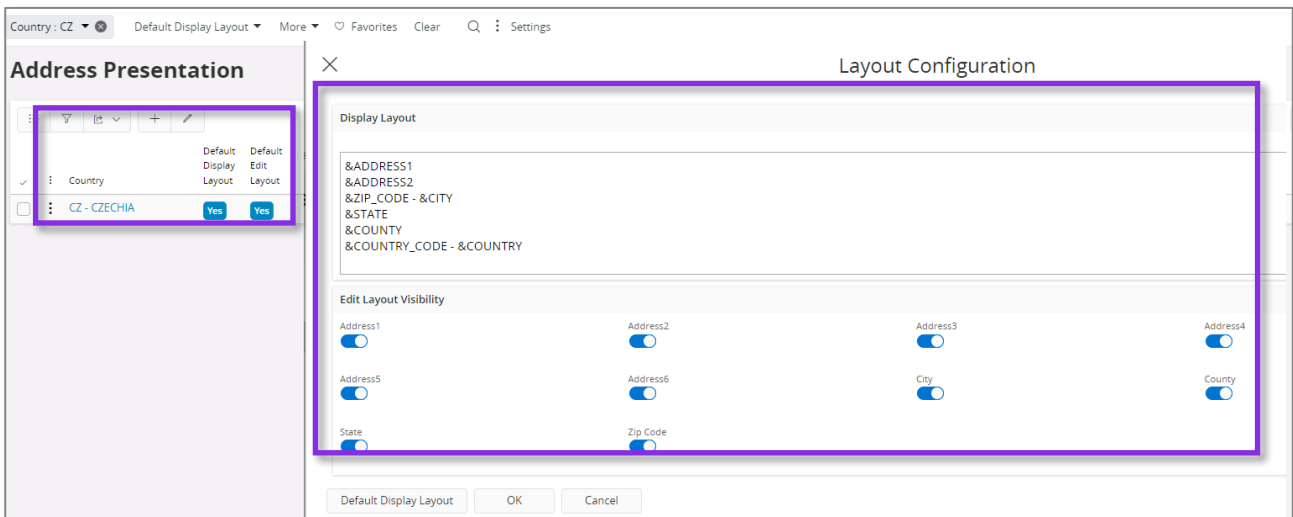

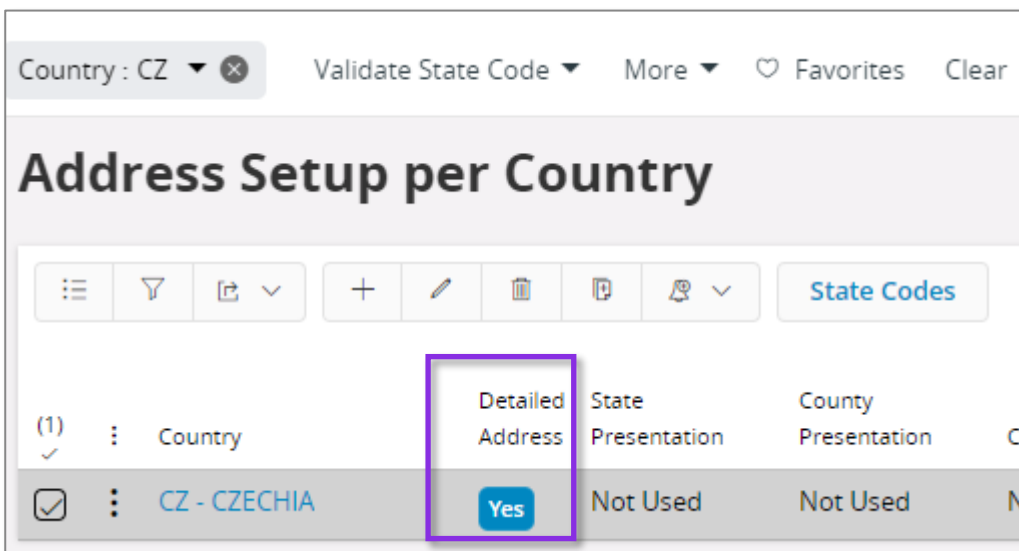
### 5.4.2 COMPANY ADDRESS

The company address is required in the header section and needs to be entered in a certain way to get the correct information into the correct field.

First, the fields for **City**, **Zip Code** and **Country** must be enabled for the Czech Republic country code in *Application Base Setup/Enterprise/Company/Basic Data/Address Presentation* page.



Second, the functionality for detail address information must be enabled. In *Application Base Setup/Enterprise/Company/Basic Data/Address Setup per Country* page the check box for **Detailed Address** needs to be checked. The check box will enable dedicated fields for **Street** and **House number** when creating the company address.



Third, enter a company address in *Application Base Setup/Enterprise/Company/Company* page *Address* tab. The dialog for address details will enable dedicated fields for **Street** and **House number** which is required in the tax report.

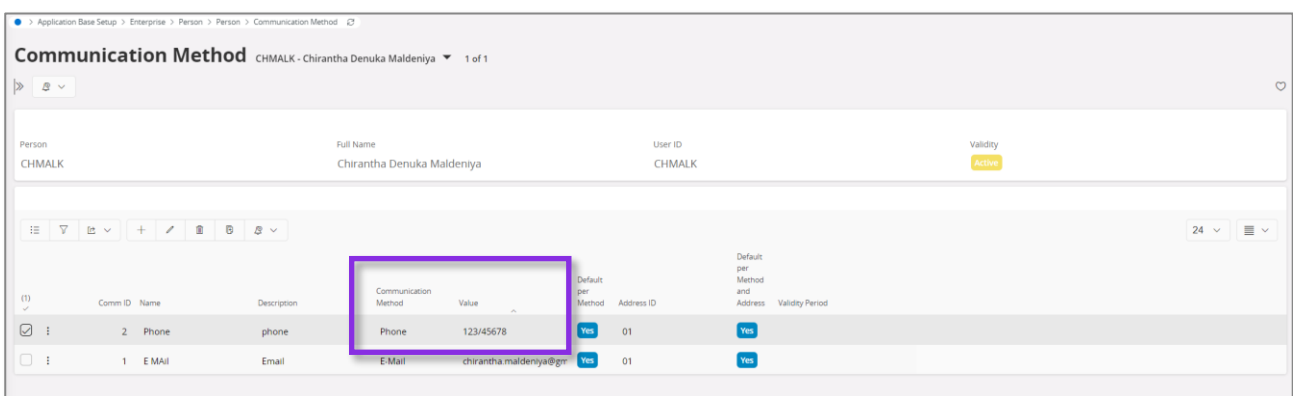

### 5.4.4 CREATE PERSON ID

The header section of the VAT report requires information about **Contact Person, Tax Consultant, Authorized Person** and **Issued By**. Use standard functionality in *Application Base Setup/Enterprise/Person* page to enter person ids which will be fetched via list of values into the header dialog when printing the tax report.

Note: Phone number must be separated from regional code by using “/” sign.



### 5.4.5 CREATE TAX REPORT

A specific tax report must be created for the VAT summary report. Use standard functionality in IFS Cloud to create the report in *Financials/Tax Ledger/Tax Report* page.

If the report is created for a quarter, then the number of periods must be set to 3.

A calculation is done to determine which quarter the report represents:

Last month in the period/3 = Quarter

Ex) Tax period April to June(6) → 6/3 = 2

Note: It is required from the user to create the report according to the calendar year i.e. Q1 = period 1 to 3, Q2 = period 4 to 6 etc.

#### 5.4.7 TAX CODES

A tax code is needed for each type of transaction, and it is the tax code that direct a certain transaction in to a certain sub section of the statement. A tax code is being created according to standard process in *Accounting Rules/Tax/Tax Codes* page.

Note: A tax code can only be connected to one tax sub group, but it is possible to direct a transaction in to another sub section by adding a delivery type i.e. for a credit or correction transaction.

#### 5.4.8 SUB GROUP DETAILS

Tax sub group is where the user connects a tax code with a certain sub section in the statement. The tax group and sub groups are fetched from the company template, if STD-CZ company template is used for company creation or company update process. The sub group details need to be set up by the user. Create a line for each tax code and delivery type that is required for the statement.

Go to *Financials/Tax Ledger/Basic Data/Tax Group* page Sub Group Details tab and search for the tax group id below and set up the sub group details. The subgroup id will be displayed in the summary report.

- 0 – Delivery of goods to another EU state
- 1 – Transfer of business assets payer to another EU state



### 5.6.2 HEADER INFORMATION

Some of the company related information for header section of the VAT control statement are taken from the information fields that have been added to the tax template.

**Company Detailed Name** - The extended company name defined field in *Application Base Setup/Enterprise/Company/Company page Address/Distribution* tab is used.

**Phone/E mail** of reporting company – The default phone no/E mail connected to the default document address of the company is used. The value with default per method and address is selected.

**House no, Street, Zip code, City and State** – All these address related details are fetched from the default document address of the company.

Note that any of this information can still be modified after creating the tax proposal but before printing the tax report. Use IFS Cloud standard functionality to view and modify the information fields connected to a tax proposal through **Show Information Fields** command in **Automatic Tax Proposal** page.

There are two different payment order files used in Czech, one for domestic payments and one for foreign payments. The format is called Multicash and contains general information and bank details for payer and receiver.

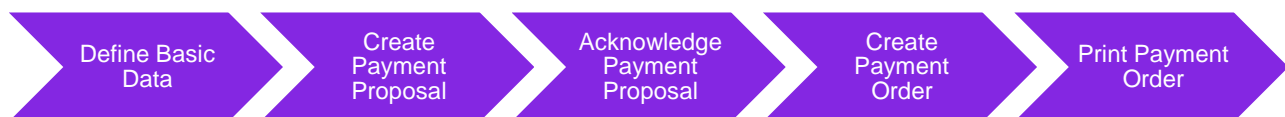

## 7 Non-Supplier Payment

### 7.1 Overview Business Requirement

It is common business practice in Czech Republic to create payments to non-suppliers e.g. employees. The payment order file for non-suppliers must contain the same information about payer and receiver as a regular supplier payment.

### 7.2 Solution

To meet this business requirement the payment formats CZMCDOM and CZMCFOR for MultiCash has been enabled for the IFS Cloud standard functionalities for **Non-Supplier Payments** and **Client Mapping**.

#### 7.2.1 PROCESS OVERVIEW



#### 7.2.2 ASSUMPTION

It's an assumption that the user is familiar with IFS Cloud standard process of creating payment proposal and payment orders for non-suppliers.

### 7.3 Prerequisite

The company must be set up to use Czech Republic localization, see the chapter and the Company Setup “*Czech Republic Payment Formats*” parameter must be enabled.

### 7.4 Define Basic Data

Set up of basic data is needed both to enable the payment format but also to enter the required information in the payment order file.

#### 7.4.1 CREATE EXTERNAL PAYMENT RECIPIENTS

Go to *Financials/Payment Basic Data/Cash Book/External Payment Recipients* and create a new **Recipients ID** and connect it to the payment method for MultiCash.

Use the command option **Recipient Specific Information** to enter the bank details for the recipient.

## 8 Access Control Inventory Transactions and Reservations

### 8.1 Overview Legal Requirements

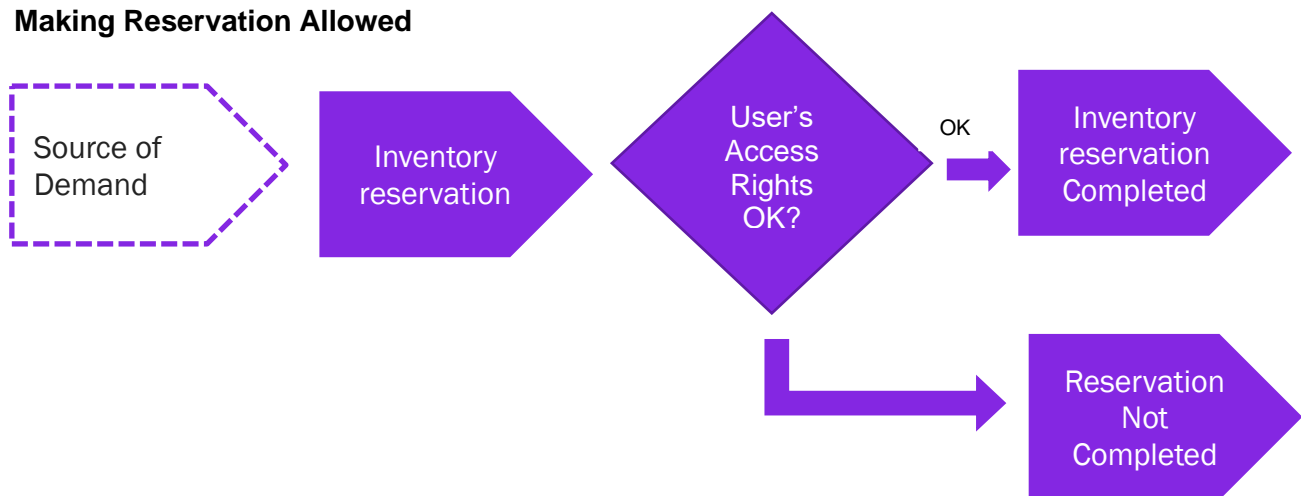
In Czech, warehouse manager or other personnel must be appointed by management as acting authority for material located in warehouses. This is a legal requirement. Due to this requirement only, authorized personnel may change quantity and/or value of material in warehouses. Warehouse access authorization is required to prevent any inventory transactions or reservations to be executed by unauthorized personnel.

### 8.2 Solution

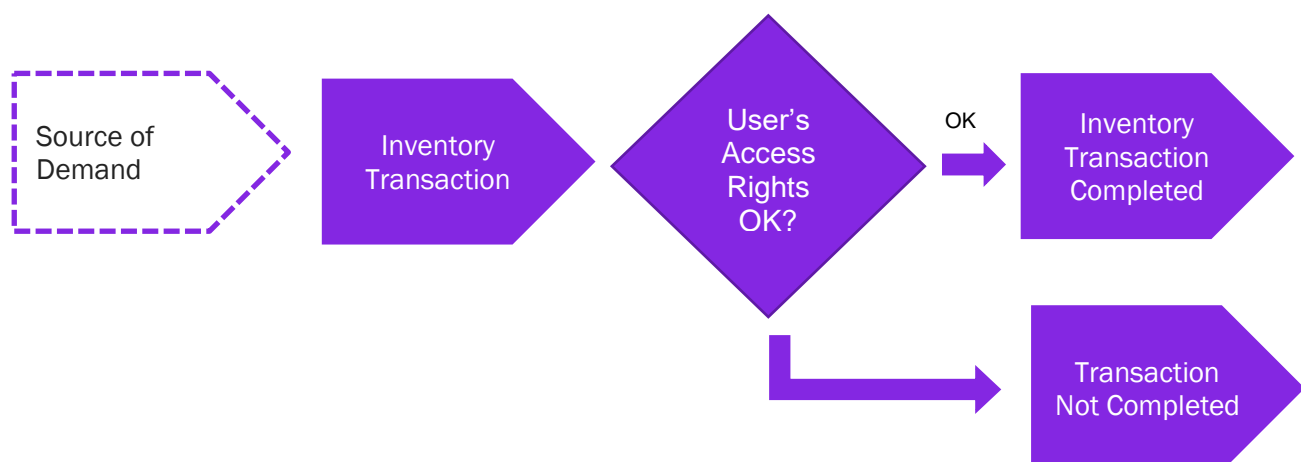
In IFS Cloud standard version IFS Cloud users are connected to sites and this connection determines the possibility to reserve inventory parts or conduct operations resulting in inventory transactions.

For IFS Czech Localization an additional level of authority is added where IFS Cloud users are connected to warehouses and given the authority to perform inventory transactions and make reservations.

**Basic Data:** A basic data page is added where the authority is set up per user over warehouses in a site. This page is Warehouse Access.

**Inventory transactions:** Controls are added when a user is saving inventory operations (e.g. receipt, scrap, pick, move, transfer between warehouses, revaluation etc.):

- If access has been granted the user can register the operation.
- If access has not been defined or not granted an error message is displayed and the user cannot proceed.

**Reservations:** Controls are added when a user is reserving inventory parts (e.g. customer order, work order, shop order, material requisition):


- If access has been granted the user can reserve the quantity.
- If access has not been defined or not granted an error message is displayed and the user cannot proceed.

### 8.3 Prerequisites

The company must be set-up to use Czech localization.

#### Warehouse Access

Use the *Warehouse Access* page to give users access to make reservations or/and transactions. Users can be added to this page and the access can be controlled over inventory reservation and transaction as required. To control an inventory transaction, enable/disable the option in the column **“Making Stock Reservation Allowed”**. To control an inventory reservation, enable/disable the option in the column, **“Performing Inventory Transaction Allowed”**





To save a record in Warehouse Access page a user must have at least one option enabled out of the 2 controls, reservation, and transaction. A record with a user whose both **“Making Stock Reservations Allowed”** and **“Performing Inventory Transactions Allowed”** disabled, is considered as an invalid record which cannot be saved.

### 8.3.1 INVENTORY RESERVATION CONTROL

Controls are added when a user is reserving inventory parts (e.g. Customer Order, Work Order, Shop Order, Material Requisition, Pick by Choice):

- If access has been granted the user can reserve the quantity
- If access has not been defined or not granted an error message is displayed and the user cannot proceed.

### 8.3.2 INVENTORY TRANSACTION CONTROL

Controls are added when a user is saving inventory operations (e.g. Receipt, Scrap, Pick, Move, Move Reserved Materials, Transfer between Warehouses, Revaluation, Attach to Handling Unit, Unattached from Handling Units, Pack According to Pack Instructions, Pack According to Handling Unit Capacity, etc...):

- If access has been granted the user can register the operation
- If access has not been defined or not granted an error message is displayed and the user cannot proceed.

When moving parts directly into the new inventory, you should have access to both warehouses, on each site. If access is not authorized, you will receive an error message.

When moving into transit at first (i.e. the goods are under transportation) you can put the material into transit, but you can move them from transit into the target location only if you have an access to that target warehouse. If access is not authorized, you will receive an error message.

Note:

- You may grant a user an access to a warehouse but not connect him to the site. In this case the user cannot perform any transactions or/and reservations.
- If the user does not have warehouse access defined or the access is set to “No”, the user cannot perform Inventory transactions or/and reservations.
- If the company’s parameter is not enabled, the effect is that no access control will occur.

## 8.4 Automatic Reservation

With the automatic reservation, the system decides under IFS Cloud standard logic from which locations and in what order inventory parts are reserved. During automatic reservation the Cloud will only reserve material from locations from/to which the user has access according to the Access Rights enabled in the **Warehouse Access** Page.

## 8.5 Exceptions in Access Rights

For changing inventory part locations between two sites, the user must be authorized to perform transactions in warehouses of both sites. During the transportation of Parts to another site, two transactions are generated: INVM-OUT (direction -) and INVM-TRIN (direction 0). The second transaction, INVM-TRIN, refers to a target location. But, if the user is not granted access to the

Warehouse in destination Site the Part cannot be moved to a destination location, so that transactions cannot be completed.

## 9 Detailed Cash Receipt Printout For Cash Box

### 9.1 Overview Legal Requirement

It is a legal requirement in Czech Republic to provide a printed receipt for all cash transactions. The content of such receipt is defined by accounting law.

*ACT 235/2004 VALUE ADDED TAX ACT*

#### **§ 30 Simplified tax document**

(1) The tax document may be issued as a simplified tax document if the total amount for fulfillment on the tax document is not higher than CZK 10000.

#### **§ 29 The tax document must contain the following data following with § 30a:**

(1) The tax document shall contain the following information:

- a) the designation of the person performing the services,
- b) the tax identification number of the person performing the transaction,
- c) the name of the person to whom the performance is affected,
- d) the tax identification number of the person for whom the transaction is carried out
- e) the registration number of the tax document,
- f) scope and subject matter of performance,
- g) the date of issue of the tax document,
- h) the date of performance of the performance or the date of receipt of the payment if, prior to the performance of the transaction, a duty arises on the date of receipt of the consideration to grant the tax or to recognize the transaction if it differs from the date of issue of the tax document,
- i) the unit price, exclusive of tax and discount, if not included in the unit price,
- j) (j) the tax base,
- k) (k) the rate of tax,
- l) (l) the amount of the tax; this tax is given in the Czech currency.

### 9.2 Solution

IFS Cloud standard report "Cash Receipt" is extended to handle following additional information, and these are added to the Report Definition Format (RDF).

- Tax identity number and association number for company
- Full address and Tax identity number of the customer or supplier
- Tax summary for "Direct Cash Payments"
- Posting information

### 9.3 Pre-Requisite

- The company must be set up to use Czech localization, see the Company Setup chapter, and the Detailed Cash Receipt Printout for Cash Box parameter must be enabled.
- Tax ID Number in Cash Box - To support this functionality, two new columns are supported in cash box for Tax ID Number and Tax ID Number Validated Date. Further, the command, Tax ID Number Validation is added to validate the tax id number entered.

Note: When Tax ID number and Tax ID Number Validated Date is present in a direct cash transaction it will be fetched to tax ledger when *Fetch Tax Ledger Information* is executed after updating relevant voucher to general ledger.

### 9.4 Printing Receipt for Direct cash transactions

As per the IFS Cloud standard process, enter a “Direct Cash Payment” in *Financials/Cash Book/Cash Box*, including the manual postings, and print the cash receipt.

To generate the XML output, navigate to Print Manager page in IFS Cloud after printing the cash receipt.

#### 9.4.1 COMPANY INFORMATION

The tax identity number and association number of the company are added to the report. The **Tax ID Number** relevant to the country of the company is fetched from *Application Base Setup/Enterprise/Company* page *Tax Control/ Invoice* tab *Tax Liability Countries* table.



## 10 Currency Rate Date Extended Capabilities For Incoming Invoices

### 10.1 Overview Legal Requirement

The Czech Republic accounting act and tax law describes different rules for translating foreign currency amounts to accounting currency in different scenarios. For supplier invoices, based on different scenarios, the user selects the accounting date for the transactions. When translating foreign currency amounts to accounting currency there can be multiple scenarios.

For example,

- For domestic purchases, the amounts in accounting currency are available in supplier invoice.
- For foreign purchases, the amounts in accounting currency are not available in supplier invoice. The net amount is translated using currency rate on the invoice arrival date. The tax amount is translated using currency rate on the invoice date.
- Other scenarios exist where different combinations are used.

### 10.2 Solution



- Define basic data.
  - Define currency rate date option for company. Two options are added to the **Incoming Invoice Currency Rate Base** parameter in *Application Base Setup/ Enterprise/ Company/ Company/ Invoice* sub menu/ *General* tab.
  - Define tax currency rate date option for company. A parameter is introduced in *Application Base Setup/ Enterprise/ Company/ Company/ Accounting Rules* sub menu/ *Currency Rate Type Information* tab, to set tax buy currency rate base when specific tax currency rates are used.
  - Define currency rate date options for supplier. Two parameters are introduced in *Application Base Setup/ Enterprise/ Supplier/ Invoice* sub menu/ *General* tab, to set invoice currency rate base and tax currency rate base per supplier.
- Enter manual supplier invoice.
  - Based on selected options for the supplier and company, the currency rate is fetched to the Manual Supplier Invoice.
- Post supplier invoice.


## 10.3 Prerequisites

- The company must be set up to use Czech Republic localization, see chapter Company Setup, and the parameter “*Currency Rate Date Extended Capabilities for Incoming Invoices*” must be enabled.

## 10.4 Define Basic Data

### 10.4.1 COMPANY

In the *Application Base Setup/ Enterprise/ Company/ Company/ Invoice* sub menu/ *General* tab select **Incoming Invoice Currency Rate Base**.

# 11 Currency Rate Date and Voucher Date Extended Capabilities for Outgoing Invoices

## 11.1 Overview Legal Requirements

According to legal regulations in countries like Hungary, Czech Republic, Slovakia or Poland, date of posting of debit sales invoices, as well as currency rates used for posting, should be based either on invoice date or on delivery date, depending on type of transaction.

Also, according to legal regulations in Poland, prepayment based invoices should be posted with the date of the payment which is the base for the invoice.

## 11.2 Solution Overview

### Process Overview

Standard invoicing flow is used in the solution:



### Solution Summary

New field **Delivery Date** is added to handle delivery dates on project invoices.

Handling of default value of the **Latest Ship Date** field on prepayment based invoices is modified, so that payment date could be the base for posting of the invoice.

New fields **Voucher Date Base**, **Currency Rate Base** and **Tax Currency Rate Base** are added to define base for voucher date, currency rate and tax currency rate for invoices. The fields are added on customer order invoices, instant invoices and project invoices. Either invoice date or delivery date can be the base for voucher date and currency rates.

New fields are added on company and customer level as sources of default values for new fields on invoices mentioned above.

## 11.3 Prerequisites

The company must be set-up to use Polish localization, see the [Company Set up](#) chapter and the “Currency Rate Date and Voucher Date Extended Capabilities for Outgoing Invoices” parameter must be enabled on the *Company/Localization Control Center* tab.

## 11.4 Set up Basic Data



Note: In customer order invoice the **Latest Ship Date** field plays role of delivery date. “Delivery Date” setting means that value of the **Latest Ship Date** field will be taken as a base for voucher date or currency rate.

The **Currency Rate** and **Tax Currency Rate** fields are based on value of either the **Invoice Date** or **Latest Ship Date** fields, depending on setting of the **Currency Rate Base** and **Tax Currency Rate Base** fields.

## 11.6 Process Invoices

### General

New functionality to define the base for voucher date and currency rates is added for following types on invoices:

- Customer order invoices – normal debit invoices (invoice type CUSTORDDEB), collective debit invoices (invoice type CUSTCOLDEB) and prepayment based debit invoices.
- Instant invoices – normal instant debit invoices (invoice type INSTINV).
- Project invoices – debit invoices (invoice type PRJINV).

For all other invoices currency rates and voucher date are handled in a standard way. In particular for correction invoices, as well as for credit customer order and project invoices, the **Voucher Date Base**, **Currency Rate Base** and **Tax Currency Rate Base** fields are always set to hidden.

### Create Invoice

When debit customer invoice (customer order invoice, instant invoice, and project invoice) is created then the **Voucher Date Base**, **Currency Rate Base** and **Tax Currency Rate Base** fields get default values based on settings on customer level. Fields which are set to “Specified on Company” on customer level get values based on settings on company level.

Note: When the **Currency Rate Base** field on customer level is set to “Specified on Company” then the **Currency Rate Base** field on invoices for this customer will get default value based on setting of the standard **Outgoing Invoice Currency Rate Base** field for company.

When prepayment based invoice is created then the **Latest Ship Date** field gets default value equal to date of payment. In standard solution this field is empty when invoice is created.

### Modify Invoice

Values of the **Voucher Date Base**, **Currency Rate Base** and **Tax Currency Rate Base** fields can be modified when debit invoice is in the “Preliminary” state with following exceptions:

- The **Tax Currency Rate Base** field can be modified only when the **Allow Specific Currency Rates for Tax Transactions** option for company is enabled.
- On instant invoice the **Currency Rate Base** and the **Tax Currency Rate Base** fields can be modified only before invoice line is entered.

Whenever the **Currency Rate Base** or the **Tax Currency Rate Base** fields get modified, values in the **Currency Rate** or the **Tax Currency Rate** fields are updated accordingly.

### Print and Post Invoice

When invoice gets printed then it will be posted with voucher date based on value in the **Voucher Date Base** field. If the **Voucher Date Base** field is set to “Invoice Date” then voucher date will be equal to value of the **Invoice Date** field. If the **Voucher Date Base** field is set to “Delivery Date” then voucher date will be equal to value of the **Delivery Date** field (or the **Latest Ship Date** field in customer order invoice).

Note: Value of the **Voucher Date Base** field has no impact on voucher date of invoices in following cases:

- When invoice is printed from the *Print Invoice* page with the **Use Voucher Date** option enabled.
- When invoice is processed from the *Customer Invoices with Errors* page with the **Use Voucher Date** option enabled.
- When invoices are processed from the *Create Collective Vouchers* page.

## 11.7 Delimitations

- Manual customer invoices are not handled.
- Outgoing supplier invoices are not handled

## 12 Internal Numbering Of Supplier Invoices

### 12.1 Overview Legal Requirement

This is a common business requirement in Czech Republic to assign sequential numbers to all supplier invoices. Invoices should be numbered in same order as they arrive into company.

For example, when entering invoice to the application, the invoice consists of two numbers.

1. Supplier invoice number (Numbering by supplier)
2. Internal invoice number (Assigned for internal purposes)

Supplier invoice number is used for tax reporting and the internal invoice number is used for internal reference and during tax authority inspections.

### 12.2 Solution Overview

- Define basic data.
  - Create an invoice series to be used as internal invoice numbering.
  - Assign the invoice series to the relevant supplier invoice type. A column is added to *Supplier Invoice Types*, to define number series for the internal invoice numbering.
- Register supplier invoice. A field is introduced in *Manual Supplier Invoice* to enter or view the internal invoice number.
- Create supplier invoice from external invoice functionality.
- Query supplier invoice. Columns are added to *Supplier Invoices Analysis and Supplier Invoice Analysis*, to query based on internal invoice number.

### 12.3 Prerequisites

- The company must be set up to use Czech Republic localization, see chapter Company Setup, and the parameter “*Internal Numbering of Supplier Invoices*” must be enabled.

### 12.4 Define Basic Data

Define invoice series for internal numbering of supplier invoices in the *Financials/Supplier Invoice/Basic Data/Invoice Series*. If internal invoice numbers should be generated automatically use the **Invoice Number Series...** command to define data for automatic numbering.

Note that automatic numbering will use invoice date for identifying valid invoice number series.

Connect internal invoice series with supplier invoice type in the *Financials/Supplier Invoice/ Basic Data/Supplier Invoice Types* page.



## 12.5 Register Supplier Invoice

When registering supplier invoice **Internal Series ID** will be filled automatically based on settings for invoice type. If internal invoice series is numbered automatically **Internal Invoice No** will be filled with generated number. Otherwise, **Internal Invoice No** is not filled automatically, and it can be entered manually when needed, or left empty.

In *Financials/ Supplier Invoice/ Manual Supplier Invoice/ More Info* dialog box, two fields are added for internal invoice series ID and No.

When supplier invoice is created automatically using functionality of *External Invoice*, **Internal Series ID** is filled based on settings for invoice type. If internal series is numbered automatically then internal invoice no will be generated.



## 13 Handle Prepayment Tax Documents

### 13.1 Overview of Legal Requirement

Sales process in Czech Republic commonly includes prepayments done by buyer before goods or services are delivered. The prepayment can be either based on an advance invoice received from seller or based on the agreement between buyer and seller. At the time of prepayment tax is not reported by either buyer or seller.

According to legal regulations, if the goods or services are not delivered within 15 days after prepayment or not delivered within the same month of the prepayment, tax should be reported on the prepayment. For reporting tax on the prepayment, a separate document is issued by the seller to the buyer. The law does not define a layout for the document but specifies the information to be included in the document. Based on the document issued by seller, buyer records the tax on prepayment.

When the good or services are delivered, the prepayments and the tax reported on prepayment are matched with the delivery invoice. The information about the matched prepayments and the tax on matched prepayment are printed on the delivery invoice. The buyer receives the delivery invoice including prepayment matching information.

If the goods are not delivered or partially delivered, any remaining prepayments are refunded to the buyer. When refunding the prepayments, any tax reported on prepayment is reversed.

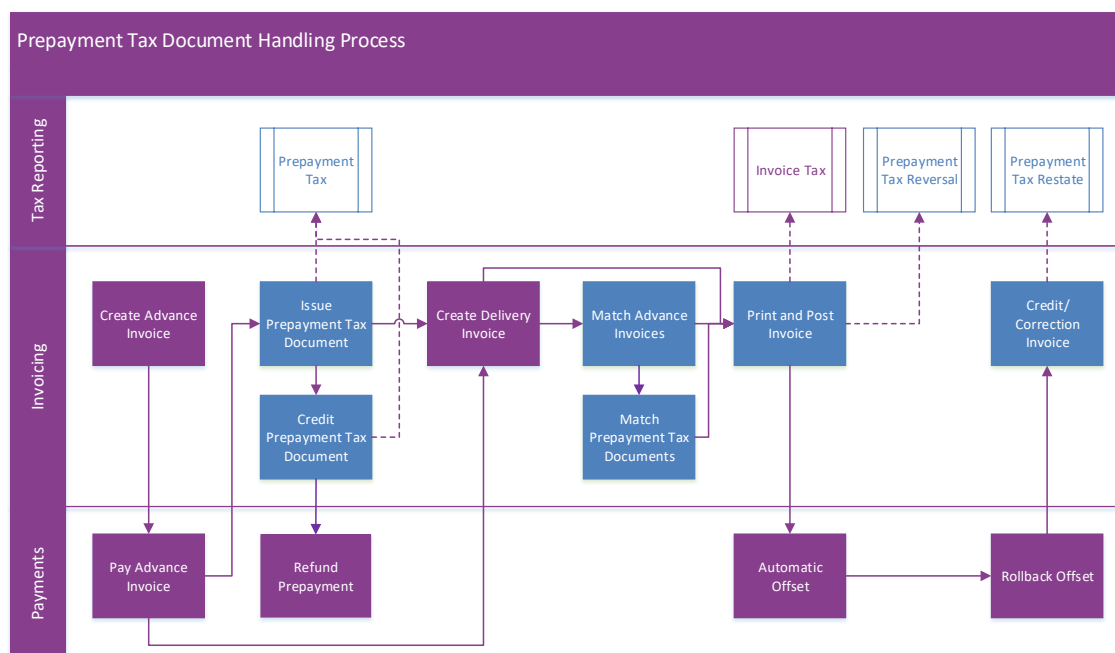

### 13.2 Prerequisites

- The company must be set up to use Czech Republic localization, see chapter Company Setup, and the parameter “*Handle Prepayment Tax Documents*” must be enabled.
- In *Application Base Setup/ Enterprise/ Company/ Company* page *Invoice/General* tab **Create Postings at Invoice Entry** option should be disabled.
- In order to handle credit invoices in instant invoice flow, the parameter “Credit Instant Invoice” must be enabled.
- If it is required to post prepayment tax documents based on prepayment types, the parameter “*Posting Prepayments Based On Prepayment Type*” must be enabled.
- If posting proposal is used for the company, enable the option **Zero Invoices Posted According to Posting Control**, in *Application Base Setup/ Enterprise/ Company/ Company* page *Invoice/Supplier Invoice Workflow* tab (This setup is optional and if this option is not enabled, a zero posting line need to be manually entered in posting proposal).

## 13.3 Handling Customer Prepayment Tax Document

### 13.3.1 SOLUTION



- Set up basic data.
  - Define default invoice types for prepayment tax documents. Four default customer invoice types are introduced to handle prepayment tax documents.
- Create and pay advance invoice.
- Issue prepayment tax document.
  - A page is introduced to see not matched customer prepayments. Prepayment tax documents are created from this page.
  - Two columns are introduced to show prepayment tax document base amount and tax amount in invoicing pages.
  - The prepayment tax document information is added to invoice report definitions.
  - The invoice posting is modified to generate entries for prepayment tax documents.
  - When prepayment type is selected, the prepayment tax documents will be posted based on defined posting control.
- Create delivery invoice.
- Match advance invoices and prepayment tax documents with delivery invoice.
  - Advance invoice matching option is enabled in customer invoice, which is same as in instant invoice.
  - Prepayment tax document matching is linked to the advance invoice matching.
- Print and post the delivery invoice.
  - The prepayment tax document information is added to invoice report definitions.
  - The invoice posting is modified to generate entries for prepayment tax documents.
- Automatic offset of prepayments with delivery invoice.
- Rollback of offset transactions.
  - The credit/correction invoice creation is modified to create credit/correction invoices with prepayment tax document lines.
- Credit prepayment tax documents due to errors or refund of prepayment.


### 13.3.2 ASSUMPTIONS

- Advance invoices are used as a request for advance payment and the process is initiated with advance invoice.
- Tax calculation structures or multiple taxes are not used.

In Application, *Financials/ Customer Invoice/ Basic Data/ Customer Invoice Types* Page define new invoice types to handle prepayment tax documents.



### 13.3.4 CREATE AND PAY ADVANCE INVOICE

Use the IFS Cloud standard customer order flow or instant invoice flow to create an advance invoice and receive payment. The advance invoice can have multiple payments received. The currency of the advance invoice is considered as prepayment tax document currency, if payment is made in a currency other than advance invoice currency.

### 13.3.5 ISSUE PREPAYMENT TAX DOCUMENT

#### 13.3.5.1 Create

Go to the *Financials/Customer Invoice/Paid Advances Not Matched* and search for the prepayment. This page shows the paid advance invoices that are not matched with delivery invoice. There can be multiple payments for a single advance invoice.

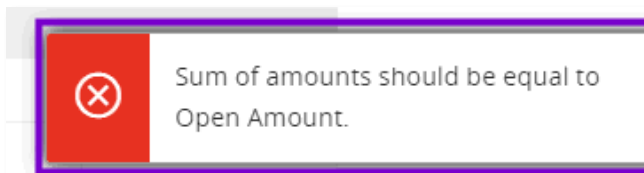



Following validations are performed when saving matched amounts of prepayment tax document lines.

- The application validates the date order of matching prepayment tax documents, as the prepayments are offset based on date order and following error message will appear.

- The application validates whether matched amounts for prepayment tax document lines is not more than matched amount of the advance invoice.

Note:

- If the advance invoices are not matched or suggested advance invoices are removed from *Advance invoice reference* dialog box, the delivery invoice will not be offset with any advance invoice.

- Do not use manual offset for matching prepayments with delivery invoices, when there are prepayment tax documents for the prepayment.



### 13.3.10 AUTOMATIC OFFSET

In instant invoice flow, the delivery invoice will be automatically offset with advance invoice as per IFS Cloud standard functionality. In customer order invoice flow, delivery invoice will be automatically offset with the advance invoices saved in *Advance Invoice Reference* dialog box.

Note: If manually offsetting prepayments, make sure that the prepayment is not connected to a prepayment tax document. Prepayments with prepayment tax documents cannot be manually offset.

### 13.3.11 RETURNING OF GOODS AND CREDITING/CORRECTING DELIVERY INVOICE

Follow the IFS Cloud standard process, to return the goods and create credit/correction invoice.



When credit or correction invoices created through return material authorization process, matched prepayment tax document lines are not created in credit invoice. It is not required to roll back the offset transaction. If the returned goods are delivered again manually offset the credit invoice. If the returned goods are not delivered and the prepayment should be refunded, create a refund for the credit invoice.

If crediting/correcting delivery invoice, without returning goods, create the credit/correction from delivery invoice. After creating credit invoice, delete the matched prepayment tax document lines. If correction invoice is created, do not edit the matched prepayment tax document lines (to make sure that there are no changes to the matched prepayment tax document). It is not required to roll back the offset transaction.


### 13.3.12 ROLL BACK OF OFFSET

If it is required to roll back offset transaction including matched prepayment tax documents, the delivery invoice should be fully credited. After matching of prepayment tax document with delivery invoice, it is not possible to partially reverse matching of prepayment tax document. Full prepayment including full prepayment tax document should be rolled back.

To handle full credit of delivery invoice in instant invoice flow or customer order invoice flow, either create a correction invoice or a credit invoice.

**Step 1** – As per the IFS Cloud standard process, use *Financials/ Accounts Receivable/ Manual Payment/ Customer Payment Rollback* page to completely roll back the offset transaction.

When the offset is rolled back, the delivery invoice **Status** is changed to “PostedAuth”. The offset transaction, including matched prepayment tax documents in *Advance Invoice Reference* dialog box will get deleted when the offset transaction is rolled back.

**Step 2** – As per the IFS Cloud standard process, use the context menu option *Create Credit Invoice...* to credit the delivery invoice.

If a credit invoice is created, the matched prepayment tax document lines will be negative.

Print and post the credit invoice. Return the goods and reprocess a new customer order.

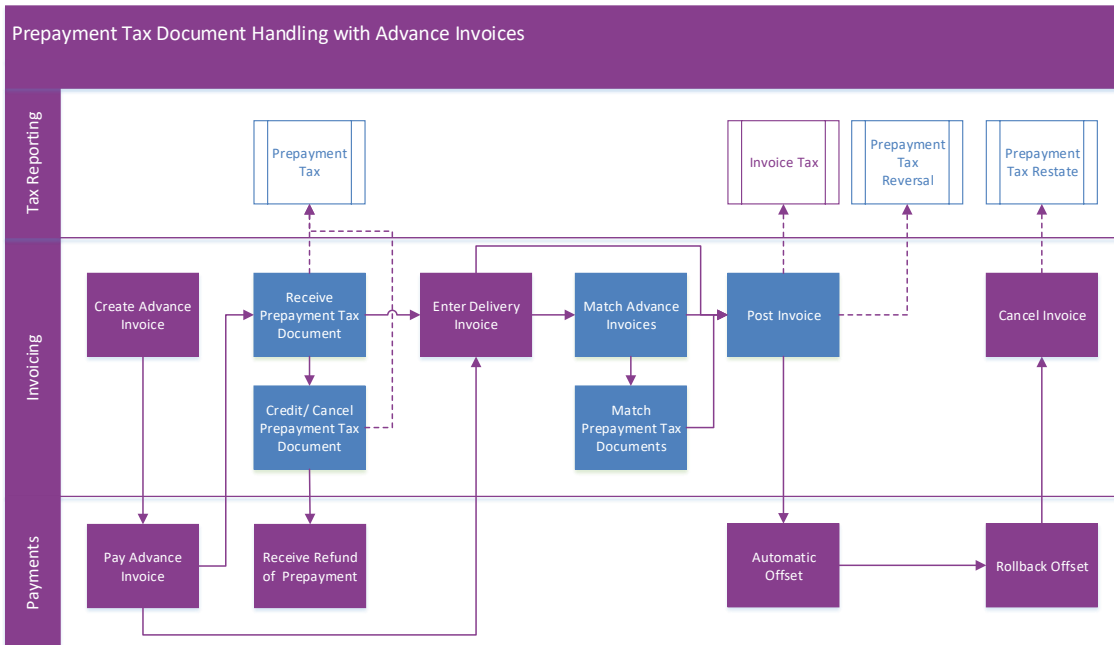
**Step 3** – As per the IFS Cloud standard process, manually offset the delivery invoice and credit invoice using *Financials/ Accounts Receivable/ Manual Payment/ Customer Offset* page.

Note : Currency Rate Correction option in invoice cannot be used roll back offset transaction, since the advance invoices cannot be matched with correction invoices.

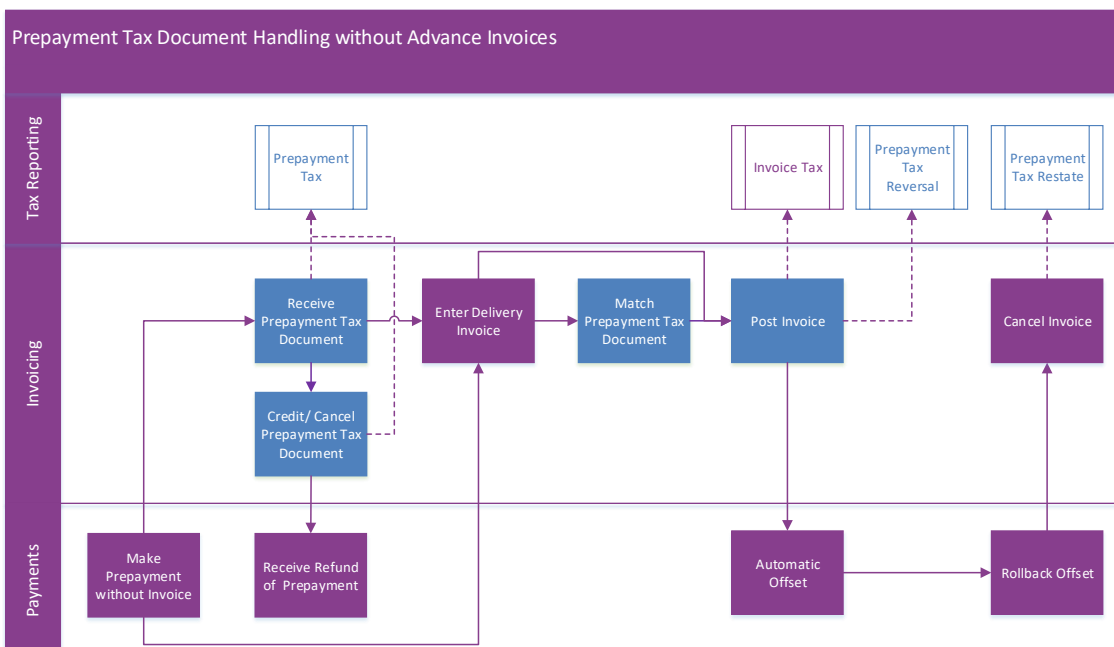
## 13.4 Handling Supplier Prepayment Tax Document

### 13.4.1 SOLUTION

#### 13.4.1.1 Prepayments with Advance Invoices



#### 13.4.1.2 Prepayments without Advance Invoices



- Set up basic data.
  - Create invoice types to handle prepayment tax documents. It is not mandatory to use separate invoice types.
- Make the prepayment.
  - Supplier payment in advance using advance invoice.

- Supplier payment in advance without advance invoice.
- Supplier payment on account.
- Enter received prepayment tax documents.
  - Create a manual supplier invoice.
  - Select prepayment number. A column is introduced in invoice header to select the prepayment.
  - A option is introduced to identify **Prepayment Tax Documents**.
  - Enter tax code, base amount and tax amount. Two columns are introduced to enter prepayment tax document base amount and tax in invoice line.
  - If required, edit the accounting currency amounts. Two columns are introduced to enter prepayment tax document base amount and tax amount in accounting currency.
- Enter delivery invoice.
- Match prepayments and post invoice.
  - If advance invoices are used, match the prepayments using the advance invoice matching command in *Manual Supplier Invoice*. Prepayment tax document matching is linked to the advance invoice matching command in IFS Cloud standard process.
  - If advance invoices are not used, match the prepayment tax documents manually in invoice lines.
  - The invoice posting is modified to generate entries for prepayment tax document matching.
- Offset prepayments.
  - Prepayments made with advance invoice are offset with delivery invoice, as per the IFS Cloud standard process.
  - Prepayments made without advance invoice should be offset manually with delivery invoice using *Mixed Payment* or *Supplier Offset Proposal*, as per the IFS Cloud standard process.
- Crediting prepayment tax documents.
  - Create a manual supplier invoice.
  - Refer original prepayment tax document.
  - A option is introduced to identify **Prepayment Tax Documents**.
  - Enter tax code, base amount and tax amount. Two columns are introduced to enter prepayment tax document base amount and tax in invoice line.
  - If required, edit the accounting currency amounts. Two columns are introduced to enter prepayment tax document base amount and tax amount in accounting currency.

#### 13.4.2 MAKE THE PREPAYMENT

Based on the advance invoice received from supplier, create an advance invoice by using the IFS Cloud standard manual supplier invoice flow. Make the payment to the advance invoice. This can be full payment or partial payment. There can be multiple payments for advance invoice.

If the prepayment is not based on an advance invoice received from supplier, enter the prepayment as a supplier payment in advance or supplier payment on account. The supplier should be selected when making the payment. This is IFS Cloud standard process.

#### 13.4.3 ENTER RECEIVED PREPAYMENT TAX DOCUMENT

Based on the document received from supplier, create a prepayment tax document in the IFS Cloud. Go to *Financials/ Supplier Invoice/ Manual Supplier Invoice* and create a new invoice. You may select a different invoice type as required. Go to *More Information* dialog box and select the relevant prepayment series and number in the **Prepayment Series ID** and **Prepayment No** fields.

2. The currency rate is fetched to the **Currency Rate** and **Tax Currency Rate** fields based on the rate used in the prepayment.
3. If **Prepayment Type** is defined in advance invoice of the prepayment, it is fetched.
4. The **Prepayment Tax Document** option is selected.

When the prepayment is made without an advance invoice, the **Reference Series** and **Reference Invoice No** field will not be filled.

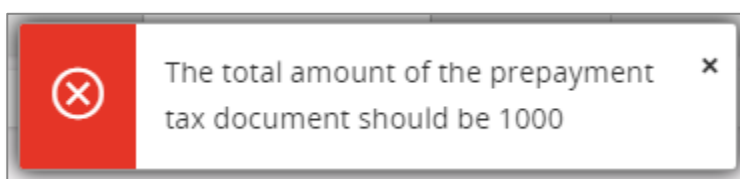
Go to lines and enter prepayments tax document lines as in the documents received from supplier. The prepayment tax document contains following characteristics.

- Header details such as invoice date are editable.
- The **Gross Amount, Net Amount** and **Tax Amount** is zero and not editable.
- The prepayment tax document tax amount and base amount are entered in the **Prepayment Tax Amount** and **Prepayment Tax Base Amount** columns. Negative values cannot be entered.
- Prepayment tax document can be cancelled in the “PostedAuth” status.
- The currency rate and tax currency rate are fetched to the prepayment tax document based on the rates used for the prepayment and they are editable.
- The amounts in accounting currency are calculated using tax currency rate and can be edited in the **Prepayment Tax Amount in Accounting Currency** and **Prepayment Tax Base in Accounting Currency** columns.

Note: Prepayment tax document can be cancelled only when it is not matched with a delivery invoice or credited.

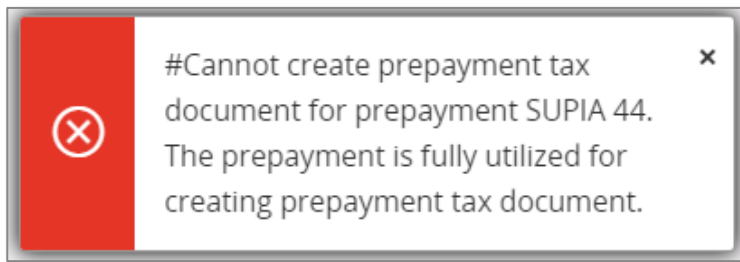
When saving prepayment tax document following validations are performed.

- The application validates whether total value of the prepayment tax document is equal to open amount of the prepayment.



- The application validates whether the prepayment is fully utilized for creating prepayment tax document.





Also, the IFS Cloud standard question message for zero invoice is appearing when saving.

If posting proposal option is enabled, the prepayment tax document will be saved in preliminary status. If option, **Zero Invoices Posted According to Posting Control**, in *Application Base Setup/ Enterprise/ Company/ Company* page *Invoice/Supplier Invoice Workflow* tab is not enabled, a zero posting line need to be manually entered in posting proposal. Follow the IFS Cloud standard process to post it.

If the posting proposal option is disabled, the prepayment tax document is posted when saving the invoice. The prepayment tax document status is changed to “PaidPosted”.

The following IFS Cloud standard postings are used for posting of the tax amounts of the prepayment tax document.

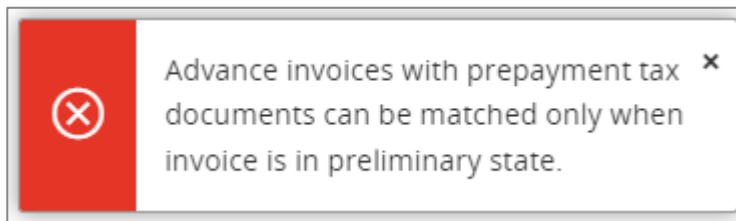

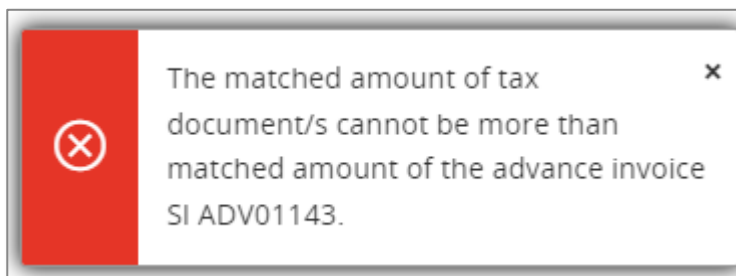
The accounting currency value of the tax reversal postings are calculated based on the delivery invoice currency rate. If the prepayment tax document currency rate is different to delivery invoice currency rate, additional postings are created for the currency difference. The currency difference is posted using PP61 – Tax Currency Loss / PP62 – Tax Currency Profit and PP41 posting types.

Following validations are performed when saving matched amounts of prepayment tax document lines.

- If there are prepayment tax documents attached to the advance invoice, the matching should be done only when the invoice is in preliminary state. In all other scenarios, the postings for reversing tax document will not be created.



- The application validates the date order of matched prepayment tax documents, as the prepayments are offset based on date order and following error message will appear, "The advance invoice II 9700017 contains not matched prepayment tax document lines with early payment date"
- The application validates whether matched amounts for prepayment tax document lines is not more than matched amount of the advance invoice.



- The matched amount of the advance invoice can be more than matched amount of the tax documents when there are prepayments without tax document. In this scenario, the application gives following warning message. If clicked on **Yes**, the amounts will be saved.



When saving following validations are performed.


The application validates whether the tax code entered for matching exists in prepayment tax document. If the tax codes not exist it will trigger the message “The entered tax code VAT10 for matching/crediting does not exist in prepayment tax document STD776.”

The application validates whether the matching amount of prepayment tax document is in line with the remaining matching amount. If not the following message will be triggered “The maximum matching amount for the tax code VAT20 of the prepayment tax document STD 780 us 113.33.”

Then, post the invoice as per IFS Cloud standard process. Tax on prepayment tax document is reversed as follows.

### 13.4.7 OFFSET OF PREPAYMENT

#### 13.4.7.1 Prepayments with advance invoices

The delivery invoice will be automatically offset with advance invoice as per IFS Cloud standard functionality when advance invoices are referred using *Advance Invoices* command.

### 13.4.7.2 Prepayments without advance invoices

After manually matching prepayment tax document and posting delivery invoice go to *Financials/ Cash Book/ Mixed Payment* page and offset the delivery invoice with the relevant prepayment. *Supplier Offset Proposal*.

### 13.4.8 RETURNING OF GOODS AND CREDITING DELIVERY INVOICE


Follow the IFS Cloud standard process, to return the goods and create credit invoice based on the credit invoice received from supplier. It is not required to roll back the offset transaction. If the returned goods are delivered again manually offset the credit invoice. If the returned goods are not delivered and the prepayment is refunded, create a refund for the credit invoice.

### 13.4.9 ROLLBACK OF OFFSET

If an offset transaction needs to be rolled back due to user errors or issue of new invoice by supplier, follow the IFS Cloud standard process.

#### 13.4.9.1 Prepayments with advance invoices

Go to *Financials/ Accounts Payable/ Manual Payment/ Supplier Payment Rollback* page and completely roll back the offset transaction. When the offset is rolled back, the delivery invoice **Status** is changed to “PostedAuth”. The offset transaction, including matched prepayment tax documents in *Advance Invoice Reference* dialog will get deleted when the offset transaction is rolled back.


### 13.4.9.2 Prepayments without advance invoices

Go to *Financials/ Cash Book/ Mixed Payment* page and cancel the payment. When the offset is rolled back, the delivery invoice **Status** is changed to “PostedAuth”. Then cancel the delivery invoice. The reversal of tax on prepayment tax document will be restated when invoice is cancelled. Enter a new delivery invoice and re-match the prepayment tax documents as per the invoice received from supplier. Then offset prepayment in *Mixed Payment*. If the offset is done in *Financials/ Accounts Payable/ Manual Payment/ Supplier Offset Proposal*, the rollback of the offset is done in *Financials/ Accounts Payable/ Manual Payment/ Supplier Payment Rollback* page.

### 13.4.10 CREDITING PREPAYMENT TAX DOCUMENT

When part of the prepayment is matched, and the remaining amount is refunded by the supplier, the prepayment tax documents attached to the prepayment are credited with remaining amount.

Based on the document received from supplier, create a credit prepayment tax document in the application. Go to *Financials/ Supplier Invoice/ Manual Supplier Invoice* and create a new invoice. You may select a different invoice type as required. Go to *More Information* section and select the relevant prepayment tax document to be credited in **Reference Series** and **Reference Invoice No.**

Go to lines and enter prepayments tax document lines as in the documents received from supplier. The prepayment tax amount and base amount are entered in the **Prepayment Tax Amount** and **Prepayment Tax Base Amount** columns. Positive values cannot be entered.

When saving prepayment tax document,

The application validates whether the tax code entered for matching exists in prepayment tax document. If the tax codes not exist it will trigger the message “The entered tax code VAT10 for matching/crediting does not exist in prepayment tax document STD776.”

The application validates whether the remaining amount of the prepayment tax document is entered for crediting. If not the following message is triggered “The total amount for tax code VAT20 should be 240 when crediting prepayment tax document STD 713”.

If posting proposal option is enabled, the prepayment tax document will be saved in preliminary status. If option, **Zero Invoices Posted According to Posting Control**, in *Application Base Setup/ Enterprise/ Company/ Company page Invoice/ Supplier Invoice Workflow* tab is not enabled, a zero posting line need to be manually entered in posting proposal. Follow the IFS Cloud standard process to post it.

If the posting proposal option is disabled, the prepayment tax document is posted when saving the invoice. The prepayment tax document status is changed to “PaidPosted”.

The following IFS Cloud standard postings are used for posting the tax amounts of the prepayment tax document.

The functionality for Posting Prepayment Based on Prepayment Type has been removed as a country specific functionality. It is now available as a generic functionality. Information and more details can be found in Finance News Presentation for the IFS Cloud 21R2.

## 14 Extended Voucher Detail Report

### 14.1 Overview Legal Requirement

It is a legal requirement in Czech Republic to print accounting documents for vouchers created based on accountable transactions and events. The accounting documents should be printed based on created vouchers and should be presented on demand during financial audit or during inspections by tax office.

### 14.2 Solution

The IFS Cloud standard report, “Voucher Detail Report” is issued as the accounting document. The following additional information are added to the Report Definition Format (RDF).

- Company address.
- Company association number.
- Voucher type and number reference in voucher header.
- Reference series and number in voucher lines.

### 14.3 Prerequisites

The company must be set up to use Czech Republic localization, see chapter Company Setup, and the parameter “Extended Voucher Detail Report” must be enabled.

### 14.4 Print Accounting Document

As per the IFS Cloud standard process go to *Financials/ General Ledger/ GL Reports/ GL Voucher Detail Report* to generate the report.
